### Incidents

**Shooting Investigation** - On May 12 at 7:18PM, officers responded to investigate a shooting that was reported to have occurred in the 15300 block of Bronco Way in Woodbridge (22193) earlier that evening. The investigation revealed the victim, a 25-year-old man, and an acquaintance were sitting inside a vehicle in the above area when they were approached by an unknown man. During the encounter, multiple rounds were fired, striking the victim and his vehicle. The acquaintance got out of the vehicle and left on foot with the shooter. The victim was treated at an area hospital for non-life threatening injuries where police were contacted. No additional injuries or property damage were reported.

***Suspect Descriptions:***

A Hispanic male last seen wearing a black t-shirt and black jeans

A Hispanic or black male last seen wearing a blue/grey shirt, tan colored pants, and carrying a firearm inside of a shirt

**Armed Robbery | Malicious Wounding** - On May 11 at 9:51PM, officers responded to the Marumscos Plaza shopping center located in the 14000 block of Richmond Hwy. in Woodbridge (22191) to investigate an assault that occurred earlier that evening. The investigation revealed the victim, a 47-year-old man, arranged a sale of suspected illegal narcotics to an acquaintance at an undisclosed location. During the encounter, the acquaintance brandished a firearm and physically struck the victim in the head causing him to fall to the ground. The acquaintance, and a second man, then took the victim's phone before leaving the area. The victim drove to the above shopping center and entered a local business where the employees contacted the police. The victim was treated at an area hospital for non-life threatening injuries and was not cooperative during the investigation. The suspect was described as a white male, approximately 5'7", 170lbs. with a nose ring.

**Burglary While Armed | Strangulation** – On May 11 at 2:27PM, officers responded to a residence located in the 13500 block of Castlebridge Ln. in Woodbridge (22193) to investigate an assault. The investigation revealed the victim, a 20-year-old woman, observed an acquaintance, identified as the accused, in her backyard. When the victim attempted to reenter the residence, the accused followed and forced his way into the home. During the encounter, the accused grabbed the victim and wrapped his arm around her neck before forcing her into another room where he struck her multiple times and brandished a firearm. At one point, the victim began to call emergency services before the accused grabbed and broke the phone. Another family member was able to contact the police. Prior to police arriving at the home, the accused left the area. The victim reported minor injuries. Further investigation revealed the accused refused to return the victim's vehicle and the following day it was recovered and returned to the victim. Following the investigation, officers obtained arrest warrants for the accused, identified as Prince Jakim Isaiiah **MALDONADO**. Attempts to locate the accused have been unsuccessful.

**Shooting into a Residential Dwelling** – On May 13 at 2:23AM, officers responded to a residence located in the 3500 block of Bath Ct. in Woodbridge (22193) to investigate a shots fired call. The investigation revealed occupants of the home woke to several shots being fired before locating damage to the home. A police K-9 and Fairfax police helicopter searched for the suspect(s) who were not located. No injuries or additional property damage were reported. Shell casings were located in the roadway.

**Reckless Handling of a Firearm** – On May 10 at 10:08AM, officers responded to investigate a destruction of property that was reported to have occurred in the 8000 block of Portwood Turn in Manassas (20109) at approximately 11:30PM on May 9. The investigation revealed multiple gunshots were heard as a vehicle quickly drove out of the area. The following morning, the caller observed damage to their vehicle and contacted the police. A bullet fragment was located on the sidewalk.

**Strong-Arm Robbery | Impersonating a Law Enforcement Officer** – On May 11 at 4:53PM, officers responded to the area of Hillendale Dr. and Dale Blvd. in Woodbridge (22193) to investigate a robbery. The investigation revealed the victim, a 57-year-old man, was walking in the above area when he was approached by an armed Hispanic man who got out of a white Nissan SUV. During the encounter, the unknown man showed a badge and identified himself as a police officer before demanding the victim's identification. The suspect grabbed the victim's wallet and took money before returning the wallet to the victim and driving out of the area. No weapons were brandished, and no injuries were reported.

**Commercial Burglary** – On May 10 at 8:21AM, officers responded to Poop Scoop Troopers located at 13164 Centerpointe Way in Woodbridge (22193) to investigate a burglary. The investigation revealed entry was forced into the building through a door sometime between 7:00PM on May 9 and 2:30AM on May 10. A key box was taken, and multiple keys were removed. A business vehicle and work items from a second vehicle were reported missing. On May 11, the unoccupied stolen vehicle was recovered in Fairfax County.

## Arrests

**Malicious Wounding | Misdemeanor Sexual Assault** - On May 9 at 10:15PM, officers responded to Paisanos Pizza located at 12439 Dillingham Sq. in Woodbridge (22192) to investigate an assault. The investigation revealed an employee, identified as Ghulam Haidar **MAHER**, inappropriately touched a 19-year-old female co-worker earlier that day. The victim reported the incident to a family member, identified as Sylvester **BACCHUS**. A short time later, a confrontation occurred in the parking lot between **BACCHUS** and **MAHER** where a verbal altercation escalated. During the encounter, **BACCHUS** struck **MAHER** multiple times with a metal tool. The parties separated and **MAHER** was treated at an area hospital for non-life threatening injuries. No other injuries were reported. Following the investigation, both parties were arrested.

**Strong-Arm Robbery** – On May 10 at 10:58AM, officers responded to the McDonald's located at 14591 Richmond Hwy. in Woodbridge (22191) to investigate a robbery. The investigation revealed an unknown man, later identified as the accused, entered the store with a large stick and then went behind the service counter. While behind the counter, the accused took a bag of food and began to walk towards the exit. An employee attempted to confront the accused who continued out of the business with the unpaid items. Officers located the accused a short distance away where he was detained without incident. Following the investigation, the accused, identified as Charles Francis **BRADLEY IV**, was arrested.
