Carried Forward from 2019 Positions:

Support funding of OmniRide/Potomac Rappahannock Transportation Commission (PRTC) Strategic Plan for transportation which enables person-centered support for Activities of Daily Living and reduction of Social Isolation to promote the availability and accessibility of transportation options for Older Adults, Persons with Disabilities and Caregivers.

(***Change to current language used by National Aging & Disability Transportation Center)

Support funding of educational programs for Older Adults, in partnership with Senior Centers, which support the Centers for Medicare & Medicaid Services (CMS) Roadmap to Address the Opioid Epidemic and Substance Use Disorders. **Substance use disorders** occur when the recurrent **use** of alcohol and/or drugs causes clinically significant impairment, including health problems, disability, and failure to meet major responsibilities at work, school, or home (SAMHSA definition; April 2019).

Support funding for educational programs on the benefits and use of Cannabidol Oil (CBD) or THC-A oil for a diagnosed condition or disease under the provisions of Virginia Code § 54.1-3408.3

From the Northern Virginia Aging Network (NVAN) approved 2020 Legislative Platform:

<u>Note</u>: If adopted by COA, use NVAN 2019 wording which will be available by September 17, 2019 October 4, 2019

Require eviction notices (5-day and 21/30 notices) to include contact information for legal assistance.

Clarify in the Virginia guardianship code that any particular clinical diagnosis alone is not sufficient evidence for a finding of incapacity.

Provide living wages, paid sick days, overtime pay, training and a career path for long-term care workers to build a quality, cost-effective workforce.

Appropriate \$974,000, 50% of full funding needed (\$1,947,873) toward bringing the state's Long-Term Care Ombudsman Program up to the state and national standard.

New Items Suggested for 2020:

Support continued funding of the 2019 Medicaid Expansion in the Commonwealth.

Expansion must be accompanied by sufficient State funding for staffing and technology for local Department of Social Services who perform the eligibility & redetermination on behalf of the State.

(*** Use Language from Virginia Municipal League (VML); COA 2017 & 2018 Legislative Priority)

Mandate Builders and Design Professionals offer for new Single Family Homes a visitability and accessibility option, as an alternative to conventional design. The Virginia State Uniform Building Code (SUBC) was amended in 2014 to include this as a voluntary option. The Universal Design Principals incorporated into SUBC improving safety features within the home (www.accessva.org) enable Older Virginians and Persons with Disabilities to "Age in Place".

(*** From COA 2016 & 2017 Legislative Priorities. Check for current language)

Fund the Virginia Housing Trust Fund

The Commonwealth should provide a stable and continuous source of adequate revenue to operate the Housing Trust Fund.

(***From COA 2018 Legislative Priorities. Check for current language from VML; Housing Virginia; and Virginia Housing Alliance.)

Affordable Housing (AFH): include defining "workforce housing" (***Check with Housing Virginia & Virginia Housing Alliance. MWCOG Regional Housing Study – may provide common language to use – "affordable" needed is \$0 to \$1300 a month rent for PW Area.)

Auxiliary (AG) Grant Funding: two points for inclusion in the statement.

- (1) Increase Reimbursement from State. (** \$1,515 as of August 2019)
- (2) State take over entire cost of funding the AG Program.
- (*** Issue within current FY2019/2020 State Budget:
- surplus funds captured from AG Program as "expenditures in the program have declined by about 12.5 percent over the past three years."
- Use of AG Funding to increase Community Capacity to develop one Assisted Living Facility (ALF) for individuals in State Hospitals with most complex & resource intensive needs with potential for transition to more integrated community setting.)
