- 3. <u>Guest Speaker/Presentation</u>: Rosemari Walker, Medicare Counselor, Virginia Insurance Counseling & Assistance Program (VICAP).
 - a. Medicare Open Enrollment Period is October 14 through December 7.
- b. Rosemari provided the currently known Medicare updates for 2020 within Parts A, B and D. Premiums for 2020 were not known at time of presentation. Discussion of the Part D Coverage Cap ("donut hole") which officially closes in 2020 and Medicare Advantage Plans. Virginia's Senior Medicare Patrol (SMP) reviewed as SMP provides education on how to detect and report when errors are noted on Medicare Summary Notices.
