Significant Progress in Bringing Plan Reviews Up to Date

The Department of Development Services is excited to report that we have nearly caught up the Building Plan Review backlog. As of Wednesday, Sept. 5, 2012, only 17 plans out of 311 Building Plans were late and pending review. This is a dramatic improvement from the 346 late plans we had on April 4, 2012.

Peak Plan Review Backlog (531 plans pending review)

- April 4, 2012
 - * 214 Architectural plans late for review
 - * 86 Electrical plans late for review
 - * 46 Structural plans late for review

Current Plan Review Backlog (311 plans pending review)

- Sept. 5, 2012
 - * 13 Architectural plans late for review
 - * 4 Electrical plans late for review

The Building Plan review workload continues to remain strong as depicted in the table below:

We will continue to work diligently to get the plan review backlog under control, and to continue to provide excellent service to our customers.

Community Development Program Created to Identify Opportunities

Earlier this year, the Prince William Board of County Supervisors authorized the creation of a Community Development program to actively promote revitalization and redevelopment throughout the County. The primary goals of this initiative, which will be housed in the Planning Office, are to link the County's land use planning and economic development functions and to identify and promote redevelopment opportunities.

The Community Development program will focus on projects that will enhance opportunities for capital investment and job creation. The program manager will work with property owners, businesses, neighborhood groups, and government agencies to identify needs and resources, to identify and address barriers to redevelopment, and to promote capital investment in the development and/or reuse of vacant or underutilized buildings and properties.

The Planning Office is developing the initial scope of work for the program, and expects to fill the Community Development program manager position this fall. For more information, please contact Chris Price at 703-792-6830.





Seasonal Safety Advisory

Did you know that according to the National Fire Protection Association, gas-fueled and charcoal grills cause an average of 900 home structure fires and 3,500 home outdoor fires? Gas grills have a higher risk than charcoal grills. Half of all gas grill and charcoal grill home structure fires begin on an exterior balcony or open porch.

The Prince William County Fire Prevention Code Section 9.1-45, Ordinance 12-09 specifies that "No charcoal cooker, smoker, grill, brazier, hibachi or any flammable liquid or liquefied petroleum gas-fired stove or similar device shall be ignited or used on the balconies or spaces under balconies of any structure or within 15 feet of any apartment building or other structure with similar occupancy".

New Development Management System Reaches Important Milestone

Prince William County's Development Management System (DMS) project team has been working on a technology improvement program project to replace the Tidemark system used by development services agencies and code enforcement with the EnerGov Enterprise system.

EnerGov technologies will streamline the County's development review and regulatory land management processes. EnerGov's software will facilitate collaboration among agencies and customers, and accelerate the review process. Once completely implemented, the new system will offer more transparency and allow for the County to expand its ability to provide leading edge technology such as electronic plan submittal and review.

The DMS team has accomplished a tremendous amount of work on this project since the contract was signed in October 2011 and has reached some important milestones. The planning and initiation phase, completed in March 2012, included tasks such as demonstrations for development staff and managers, creation of the project plan, and identifying current hardware needs.

As the project transitioned into the next phase, Assess and Define, core implementation team members received training in systems administration and participated in sessions that provided detailed analysis of the County's GIS system. The training sessions helped to provide an in-depth and behind-the-scenes understanding of the EnerGov product and how it will work with Prince William County business processes and data.

In August 2012, the project team signed off on the Assess and Define phase of the project, reaching a major milestone. This phase included a massive effort by the project team and approximately 60 subject matter experts (SMEs) from all of the development services agencies to map out flowcharts of all of their business processes and then input those into an EnerGov system workflow.

The project team, with the help of the SMEs, also completed a thorough analysis of Ener-Gov system capabilities and created specifications for 40 different custom enhancements, including online customer access features, interfaces with existing enterprise systems, and a new EnerGov module to manage the County's proffer processes.

The project team and the SMEs are very excited to be entering the Configuration and Review phase. The focus for the team will now turn to preparations for data conversion, hardware installation and configuration, as well as testing.
