What's New in Emergency Management

- EM staff installed an antenna and associated hardware in the 8490 Kao Circle Warehouse to support radio communications.
- EM leadership conducted interviews for two vacancies in the program.
- EM staff hosted and facilitated the Public Safety Branch meeting in the Emergency Operations Center (EOC). The purpose of the meeting was to establish expectations regarding EOC positions, qualifications and responsibilities that will be outlined in the Emergency Operations Plan revision.
- EM staff began initial coordination with various agencies, both county and around the National Capital Region, regarding the excessive heat that enveloped the area from Thursday, July 18th through Sunday, July 21st.
- On Friday, July 19th, EM staff participated in the regional full-scale Capital Fortitude Exercise (see photos below). The exercise centered around an anthrax release scenario and the multi-jurisdictional point-of-dispensing process. Capabilities being evaluated included: Information Sharing, Medical Countermeasure Dispensing, Logistics and Supply Chain Management, and others. EM staff participated by loading and delivering supplies from the Kao Circle Warehouse to Metz Middle School in Manassas, by going through the point-of-dispensing process, and by providing personnel to assist with Controller duties.







- EM staff met with representatives from the City of Manassas and Manassas Park to discuss
 establishing a Citizen Corps Council partnership, which would strengthen the various programs such
 as the City and the Park's Community Emergency Response Teams, all Worship Watch and
 Neighborhood Watch programs, Medical Reserve Corps, and others.
- EM staff presented information on Hurricane Preparedness to the Town of Dumfries staff during their week-long retreat, which was centered around physical and mental wellness. The Hurricane Preparedness presentation was followed by Active Violence training delivered by Officer M. Whaley.

August is Back to School Safety Month Pedestrians, Like Drivers, Are Responsible to Stay Alert While Traveling

Everyone is a pedestrian, at some point throughout the day, whether traveling by foot, bicycle, wheelchair, stroller or similar means. As pedestrians, we're at constant risk of being injured or killed from traffic crashes. According to the Governors Highway Safety Association, pedestrian fatalities, in the U.S., are on the rise, having increased 4% in 2017, the highest mortality rate since 1990.

August is Back to School Safety Month, a reminder to motorists the school year is about to begin and to be vigilant when driving. Many school and bus routes are improperly designed and pose a serious hazard for children due to the lack of sidewalks or crosswalks, wide



roads and speeding drivers. According to the 2017-2018 National School Bus Loading and Unloading Survey, 6 student fatalities occurred during the school year; these students were killed either by their own school bus or by a passing motorist while loading and unloading the bus. Therefore, when driving, whether taking your kids to school or driving near a school or bus stop, be on the lookout for children loading and unloading the bus or walking and riding to and from school.

The school year, for Prince William County Public Schools, begins Monday, August 26th. To keep you and your loved ones safe, the Prince William County Fire and Rescue System urge pedestrians and drivers to follow these simple safety tips:

DRIVERS

- Slow down, follow the speed limit and be alert especially in the residential neighborhoods and school zones.
 - Look for pedestrians everywhere. Pedestrians may not be walking where they should be or may be hard to see — especially at night, in poorly lit conditions, including dusk/dawn/night and in poor weather.
- Take extra time to look for kids at intersections, on medians and on curbs.
- Enter and exit driveways and alleys slowly and carefully.
- NEVER pass vehicles stopped at a crosswalk. There may be people crossing that you can't see.
- Watch for children on and near the road in the morning and after school hours.
- Reduce any distractions inside your car so you can concentrate on the road and your surroundings.
 - Put down your phone and don't talk or text while driving!

KIDS

- **ALWAYS** cross the street with an adult, at least up until age10, when your traffic skills and judgment are better.
- Cross the street at corners, using traffic signals and crosswalks whenever possible.
- **NEVER** run out into the street or cross in between parked cars.
- Wear reflective material or clothing and carry a flashlight to increase your visibility at night.
- ALWAYS walk in front of the bus, at least 10 feet, where the driver can see you.
- If waiting for a parent, wait on the same side of the street as the school bus loads and unloads.
 - DO NOT play in driveways, streets, parking lots and unfenced yards next to the street.

ADDITIONAL PEDESTRIAN SAFETY TIPS

- Make eye contact with drivers prior to crossing in front of them. Don't assume that because you can see the driver, the driver can see you.
- Look left, right and left again when crossing a street and continue looking while crossing.

 It's safest to walk on a sidewalk, but if you must walk in the street, walk facing traffic.

Volunteer Firefighter Recruit Graduation Ceremony



On Wednesday, July 17th, at 7:00 p.m., the Prince William County Fire & Rescue System held its Volunteer Firefighter Recruit Graduation Ceremony at the Public Safety Training Center located at 13101 Public Safety Drive in Nokesville, Virginia. Battalion Chief Mike LaSalle presided over the ceremony. Assistant Chief James Forgo and Volunteer Chief Jerry Deem provided an inspirational message to the recruits and attendees.

Recruit Class 19144 consisted of 11 recruits who successfully completed 6 months of rigorous academic and physical training at the System's Public Safety Training Center. Each student performed 420 hours of training which consisted of 300 hours of Firefighter I & II, 40 hours of Self-Contained Breathing Apparatus Training, 40 hours of Hazardous Materials Training (up to the Operations level), Liquid Petroleum Gas Training and 4 days of Firefighter Survival Training. Upon graduation, they will be designated as Firefighter.
