Training 911 EMT Graduation

On Monday, April 1st, at 7:00 p.m., the Prince William County Fire and Rescue System held its graduation ceremony for Training 911 EMT Class 19146 at the Public Safety Training Center in Nokesville, Virginia.

Chief Tom Wood of Stonewall Jackson Volunteer Fire & Rescue presided over the ceremony.

Class 19146 consisted of 13 students who successfully completed 14 weeks, over 160 hours, of intense academic and practical training, from November 2018 through

February 2019. During that time, they were trained to recognize and manage a variety of emergency situations for patients who had suffered traumatic injury or a medical crisis by utilizing basic life support skills such as airway management, Immobilization of specific injuries, control of hemorrhage and shock and administration of basic medications. In addition, they learned implementation of triage for mass casualty incidents. Upon completion of the course and exams administered by the Virginia Office of Emergency Medical Services and the National Registry of EMTs, the students received their certification as an Emergency Medical Technician (EMT).

National Window Safety Week April 7 – 13, 2019

Spring has arrived and as the weather becomes warmer, households will turn off their home heating equipment and begin inserting window screens to enjoy the cool spring breeze that a screen provides. While screens for some may be comforting, for others they are dangerous even deadly especially for small children.

Each year, children die and are injured from window falls. Children under the age of 5 are at the highest risk for such falls due to their curiosity and/ or focus is elsewhere, such as a toy, a pet or any number of things while playing near a screened

window resulting in an unintentional injury or death. Although the majority of children that fall from windows reside in urban areas, falls do occur, from a first or second-story window, in homes or apartments.

National Window Safety Week is April 7th – 13th. The Prince William County Fire & Rescue System, in conjunction with health and safety organizations/agencies across the U.S., are urging the public to get involved, year round, at home, school and neighborhoods to help reduce unintentional injuries among children by understanding the role of windows. Windows are two-fold; while vital in escaping a home fire or other emergencies, parents and guardians need to understand the importance of protecting against accidental window falls. Listed below are window safety tips to keep your little ones safe:

Window Safety Tips

- · Keep children away from open windows.
- Install window guards or window stop devices that prevent windows from opening more than 4 inches (educate family members, older children and adults, on how to release window guards in the event of a fire or other emergency that requires evacuation).
- Keep climbable objects, i.e. furniture, beds, toy chests, etc., away from windows.
- DO NOT place toys and other inviting objects on windowsills.
- Check to make sure porch and balcony railings are spaced 4" apart or less.
- Always provide adult supervision for children around open windows or in risky environments.

Acting System Chief Tim Keen of the Prince William County Fire and Rescue System states, "It's important to remember that windows play a vital role in fire safety and should be considered as an alternative exit when planning a home fire escape plan. It's also important to remember that windows pose a threat to young children when left open and unattended. Be proactive in taking the necessary precautions of safely securing windows to ensure your child's safety."



Exposure Control Program

Over the past year, the Department of Fire & Rescue Health & Safety Officers spent countless hours improving the Exposure Control Program; a critical component of their jobs. DFR Health and Safety Officers are the main point of contact for handling any type of exposure (airborne, blood borne, etc.) involving county employees.

Over the last twelve months, the following improvements have been made to the Exposure Control Program:



- The Health and Safety Officers effectively managed 160 exposures
- The Health & Safety Officers worked with Novant to improve the process for expediting lab work due to an exposure
 - As a result, Novant has recently implemented a new protocol which has improved communications substantially
- The Health and Safety Officers have worked with the state to become a self-certifying agency enabling them to teach the Designated Infection Control Officer training (to be completed in July 2019).

Illicit Drug and Opioid Safety Training

Matt Adkins (Fire & Rescue) and Alexander McMillan (Police)

Opioid use and addiction has become an epidemic throughout the County and Prince William County is not immune from this crisis. In 2017, Executive Management requested Police and Fire & Rescue create a Synthetic Opioid Task Force to develop personal protective equipment guidance and contamination avoidance training for all police and fire personnel to protect themselves from these hazardous materials. Since non-public safety employees provide services, in the community, the need to provide awareness training to these employees was essential. Matt and Alex developed

training on "Illicit Drug and Opioid Safety" providing information on awareness, recognition and personal safety for these employees. Matt and Alex developed training for non-public safety employees to identify potential exposures, how to prevent any exposures and what to do in the event of an exposure. The training was very popular and was requested by other departments who have employees working in the field.

2019 Governor's Environmental Excellence Awards

On March 28th, the 2019 Governor's Environmental Excellence Awards held its 30th Environment Virginia Symposium in Lexington, Virginia. The awards recognized the significant contributions of environmental and conservation leaders in four categories: sustainability, environmental project, land conservation, and implementation of the Virginia Outdoors Plan. Prince William County Department of Fire and Rescue received a Silver Medal for its Smarter Chemicals Program.

Smarter Chemicals Program


The Department worked with others in the County to develop a Smarter Chemicals product list. It was found that the average fire station had over 40 different cleaning products, compared to an average of eight for custodial companies hired by Prince William County.

A review, of employee injuries, revealed that many "slips and falls" were related to inappropriate dilutions of cleaners leaving floors slick and many "strains and sprains" were related to heavy products. The Smarter Chemicals Program has reduced employee injuries, decreased damage to facilities due to improper dilutions, limited exposure to potentially hazardous substances, cut excessive purchasing and the resulting disposal costs, and minimized the effort to maintain Safety Data Sheets. On average, 116 cleaning chemicals with safety hazards were eliminated from each fire station.
