MEMORANDUM OF UNDERSTANDING FOR NORTHERN VIRGINIA FAMILY SERVICE

This Memorandum of Understanding (MOU) is between PRINCE WILLIAM COUNTY (County), by and through the Juvenile Court Service Unit, and Northern Virginia Family Service (CP). The terms and conditions of this MOU govern the actions and obligations of the CP, in addition to the requirements of all applicable local, state, and federal laws and policies. During the next fiscal year the County agrees to provide donations listed in Attachment A (Adopted BOCS Budget Funding Provided to Community Partners) and CP agrees to provide those services as identified by Attachment B (County Budget Documents), according to the amounts, terms, and conditions set forth below.

WHEREAS:

A. The CP represents that it is an independent, non-profit 501(c) (3) organization authorized to do business in the Commonwealth of Virginia. The CP's mission is to <u>To empower individuals</u> and families to improve their quality of life, and to promote community cooperation and support in responding to family needs.

B. The County recognizes that the provision of public funds can allow the CP to expand services for the benefit of the community, as part of its comprehensive and coordinated delivery of services to the community, which may increase community participation in the delivery of services.

NOW THEREFORE, the County and CP agree that:

1. The County will provide to CP local donation, in the amount of One Hundred Eleven

Thousand One Hundred Eighty Dollars (\$111,180) approved by the Prince William Board of

County Supervisors to be used during the period of July 1, 2021, through June 30, 2022, to provide CP services within Prince William County as listed in Attachment B.

- 2. This MOU will be in effect from July 1, 2021 through June 30, 2022. The CP acknowledges that the appropriation of this donation is limited to the year specified in this MOU and implies no expectation of future donations.
- 3. The parties acknowledge that the funds provided are a donation and that the Board of County Supervisors asserts no control over the day-to-day operation of the CP program. CP is a grant recipient of the County and is not an agent of the County. Therefore, the CP shall indemnify and hold harmless the County for any claims for bodily injury, death or property damage rising from any alleged negligence, willful misconduct, omission or wrongful act of the CP. CP shall procure and maintain, at its own cost and expense, any kinds and amounts of insurance that, in its own judgment, may be necessary for its proper protection in its work as described in this MOU.
- 4. All donations under this MOU are conditioned upon the appropriation by the Prince William Board of County Supervisors.
- 5. By the end of the fiscal year in which the donation is made, the CP will submit an invoice or letter, on CP letterhead, to the **Juvenile Court Service Unit** requesting disbursement of the approved donation.
- 6. By the end of the fiscal year in which the donation is made, the CP shall report to the Juvenile Court Service Unit their receipt of the donation, and shall certify the expenditure of the donation was in accordance with Attachment A. If the report and certification is not to the satisfaction of the County, the County may request the return of all donations received under this Agreement for which the CP has not demonstrated an appropriate expenditure.

7. If requested, and in accordance with Prince William County Code 2.1, if applicable, the CP shall provide copies of the CP's most recently completed annual IRS form 990 and annual or biannual reviewed, compiled or audited financial statements to their assigned host agency.

The mission of Northern Virginia Family Service is "to empower individuals and families to improve their quality of life, and to promote community cooperation and support in responding to family needs." To achieve this mission, NVFS establishes and sustains programs, projects, and partnerships that engage a wrap-around approach to uncovering and eliminating barriers to independence for the most vulnerable individuals and families in Northern Virginia.

Provide a brief description of your organization.

Northern Virginia Family Service was established in 1924 to mobilize community support for Alexandria families who lacked access to basic necessities such as food, coal, clothing, and medicine. Over the past 95 years NVFS has evolved to meet the changing needs and challenges of the overall region, pioneering an effective service delivery model that responds to more than 34,000 individuals and families annually. NVFS consists of eight core service areas, including Early Child Development (Head Start, Early Head Start, and Healthy Families); Foster Care (Therapeutic Foster Care and Respite Care); Health Access, Food Assistance, and Nutrition Services; Housing and Homelessness Services; Immigration Legal; Trauma-Informed Mental Health and Case Management; Workforce Development; and Youth Initiatives. Today NVFS' expansive service areas encompass the operation of several program centers, including five Child

The IPE Program of NVFS is an asset development intervention designed to increase the protective factors that ensure that gang involved youth, and youth at risk for gang involvement, have increased abilities to resist the destructiveness of gang involvement and that their parents and community members are able to provide the support and structure needed to keep these vulnerable youth safe from the negative influence of gangs.

IPE serves youth ages 10-21, and their family members, who are or have been affected by gang involvement:
