### Incidents

**Aggravated Assault** - On June 6 at 2:18AM, officers responded to the parking lot of the Marumscos Plaza Shopping Center located at 13901 Jefferson Davis Hwy. in Woodbridge (22192) to investigate an assault. The investigation revealed that the victim, a 30-year-old man, was in the parking lot when he was approached by four unknown men. During the encounter, the victim was struck several times by the individuals before a patron intervened. The group then fled on foot. The patron contacted emergency services, prompting the police investigation. The victim was transported to an area hospital with non-life threatening injuries. The suspects were only described as being Hispanic men.

**Brandishing of a Firearm | Road Rage Related** - On June 4 at 5:18PM, officers responded to the 14100 block of Whitney Rd. in Gainesville (20155) to investigate a brandishing. The victim, a 24-year-old man, reported to police that while driving southbound on Linton Hall Rd., a black Nissan sedan pulled in front of his vehicle. After a short distance, both vehicles stopped for the traffic light at Linton Hall Rd. and John Marshall Hwy where the victim observed the other driver brandish a firearm. The victim and the suspect then pulled into a parking lot near Whitney Rd., where the suspect exited his vehicle and a verbal altercation ensued. No firearm was observed during the verbal encounter. Eventually, the parties separated, and the police were contacted. At no time were shots fired or was there any physical contact between the victim and the suspect.

***Suspect Description:***

A white male, with blond hair and a scraggly beard

Last seen wearing a white tank top, basketball-style shorts, and a full sleeve tattoo

**Attempted Commercial Burglary** - On June 6 at 12:05AM, officers responded to Todos Supermarket located at 16593 River Ridge Blvd. in Woodbridge (22191) to investigate an alarm activation. Upon arrival, officers observed a side door slightly ajar. The investigation revealed that entry was attempted through either the unsecured roof top door or the side door. No entry was made into the business and no property was reported missing.

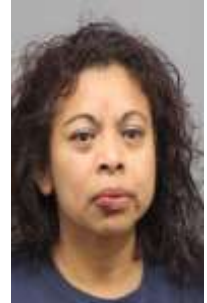

## Arrests

**Assault and Battery on a Law Enforcement Officer [LEO]** – On June 6 at 6:06AM, officers responded to the intersection of Jefferson Davis Hwy. and Bel Air Rd. in Woodbridge (22191) to investigate a single vehicle crash. Upon arrival, officers located a vehicle with significant damage that was still running and in gear. The driver, later identified as the accused, refused to exit the vehicle. While investigating, officers determined that the accused was intoxicated and located an open container of alcohol in her vehicle. When officers attempted to detain the accused, she actively resisted and refused to follow officer's commands. After a brief struggle, the accused was taken into custody without further incident. During the encounter, the accused pushed and struck an officer. The accused was transported to an area hospital for further processing and evaluation. No injuries were reported by the officer. Following the investigation, the accused, identified as Evelyn Areli **CABRERA**, was arrested.
