## **EVOC REMEDIAL**

This training is used to refresh the skills that are taught in basic training and is geared toward law enforcement personnel who have been involved in a crash while on duty. When possible, emphasis will be placed on the individual's area of difficulty. Elements of the basic school that may be covered in this class include defensive driving lecture, vehicle inspections, overview of electronic stability control, ABS and threshold braking circuit, crash avoidance circuit, combined skills course, line-of-travel and "below 100" and Virginia Code 46.2-920 review. Members must provide a vehicle for this training, and there is a maximum of eight enrollments per date from PWCCJA.

**\*NEW\* FIGHTING FENTANYL**

Fentanyl is quickly becoming one of the most dangerous and challenging drug-related threats to communities and law enforcement officials across the United States. Day one of this training course will focus on breaking down Fentanyl as well as the latest trends in packaging and distribution. An emphasis will be placed on how to protect yourself from accidental exposure and possible overdose by using proper protective equipment. Officers will learn how to recognize the symptoms and respond to an officer overdose. The proper technique for naloxone deployment will also be presented. An emphasis will be placed on how to collect, process, and preserve Fentanyl evidence while minimizing exposure. Example policies and procedures will also be presented. The second day of the training course will focus on investigative techniques involving Fentanyl cases.

## EVOC SKILLS REFRESHER

This one-day class emphasizes all aspects of safe emergency vehicle operations. The class covers: vehicle inspections (discussion of Ford Police Interceptor AWD platforms), overview of electronic stability control, precision driving, line-of-travel, challenge course, skid control and off-road recovery, emergency response, pursuits, stop-stick deployment and "below 100" and Virginia Code 46.2-920 review. Members must provide a vehicle for this training, and there is a maximum of eight enrollments per date from PWCCJA.

## EFFECTIVE REPORT WRITING

This course teaches students how to write effective report in use of force, domestic assault, and other challenging cases. Special emphasis is placed on clear articulation of the basis for using force, observations of events and injuries, and careful documentation of potentially exculpatory and Brady evidence. Instruction includes legal issues as well as practical exercises. The class is designed for new and experienced law enforcement officers who want to make their reports more effective in court as tools of communication with prosecutors, judges, and lawyers in the justice system.
