DSS Lead Agency Update:

- Virginia Homeless Solutions Program (VHSP) Funding
 - One VHSP Rapid Re-Housing program received a reduction of approximately \$8,000. The equivalent of what was not expended in the last grant cycle.
 - The second Rapid Re-housing program had to repay \$64,000 back to the Department of Housing and Community Development (DHCD).
- Emergency Food Shelter Program (EFSP)
 - EFSP funding is now available for hotel stays and prevention.
- Emergency Housing Voucher Program (EHVP)
 - Emergency Housing Voucher workshop was held on July 29, 2021.
 - Tony shared the EHVP background of referrals made to date (see attachment).
 - The list will be prioritized on 8/16/21 so referrals can be sent to Prince William County and the city of Manassas to begin the EHV process.
 - Next step: The referring agency and EHV staff will receive an email indicating that a household has been referred.

Organizations should continue with referrals. As vouchers are quickly processed, there is the possibility of receiving additional vouchers.

- HUD Grant
 - The Community Application deadline for applications for the 2021 HUD application has passed.
 - \circ The PAR Committee will be meeting on 8/17/21 to evaluate the applications.

Bylaw Information Update
