Incidents

False Report of School Shooting – On November 9 at 11:42AM, the Prince William County Public Safety Communications Center received a call from an individual reporting a shooting-in-progress at Woodbridge High School, located at 3001 Old Bridge Rd in Woodbridge. The School Resource Officer (SRO) was present at the school at the time of the call and immediately took action to investigate the incident. Additional SROs and patrol officers arrived at the school within minutes and secured the building. Fire & Rescue personnel also responded and staged nearby in the event injuries were found while other schools in the immediate area were placed in a secured status as a precaution. Officers conducted a methodical search of the Woodbridge High School grounds which resulted in no evidence of a shooting being found and no injuries reported. After completing the search of the grounds, the call was determined to be unfounded and the school resumed operations as police began to demobilize from the area. Officers plan to remain at the school through dismissal for security purposes. The investigation into the initial call made to the communications center is continuing.

Malicious Wounding | Domestic Related – On November 8 at 12:53PM, officers responded to the Shenandoah Station Apartments located in the 19300 block of Belleau Wood Dr. in Triangle (22172) to investigate a domestic. The victim, a 26-year-old woman, reported to police that an acquaintance, identified as the accused, entered her apartment, and began a verbal altercation. During the encounter, the accused forcefully grabbed the infant child from the victim's arms and ran into another room. When the victim entered the room after the accused, he struck her with a glass figurine on the head. The victim was able to take the infant child and went to a neighboring apartment where police were contacted. The accused fled prior to police arrival. The victim reported minor injuries and no injuries were sustained by the infant. Following the investigation, officers obtained arrest warrants for the accused, identified as Travis Xavier **TIMMONS**. Attempts to locate the accused have been unsuccessful.

Arrests

Burglary While Armed – On November 4 at 5:19PM, officers responded to The Residences at Somerhill Farms Apartments located in the 7300 block of Yountville Dr. in Gainesville (20155) to investigate a home invasion. The investigation revealed that four male juveniles entered an apartment and brandished a firearm towards the residents. During the encounter, there was a brief verbal altercation before the suspects went into one of the bedrooms. While in the bedroom, the suspects removed items before fleeing in a vehicle. No injuries were reported. On November 5, detectives with the Violent Crimes Unit received information identifying one of the suspects as a **16-year-old male juvenile**, who was taken into custody later that evening. While investigating, detectives identified and obtained a detention order for a second suspect, identified as a **15-year-old male juvenile** who was located and taken into custody by members of the Manassas Park Police the following day. The case remains active as detectives seek to identify the two additional suspects.

Child Neglect | Aggravated Malicious Wounding – On November 5 at 3:34AM, officers responded to the Potomac Vista Apartments located in the 14100 block of Bay Vista Dr. in Woodbridge (22191) to investigate a domestic with weapons. The investigation revealed that the victim, a 25-year-old woman, and an acquaintance were involved in a verbal altercation when the accused brandished a firearm. At some point, the victim attempted to lock herself in the bathroom to contact the police. The accused broke down the door, struck the victim and took her phone before brandishing the firearm towards the victim again. The accused then took their infant child, who was in the apartment during the incident, and fled the residence. The victim reported minor injuries. Officers located the accused in the Woodbridge area and took him into custody without incident. The infant child was not injured. Following the investigation, the accused, identified as Ayestas Alexis **ROMERO**, was arrested.

Abduction | Domestic Related – On November 5 at 2:30PM, officers responded to a residence located in the 12600 block of Dulcinea Pl. in Woodbridge (22192) to investigate an assault. The victim, a 33-year-old woman, reported to police that an acquaintance, identified as the accused, made threats towards her. The victim went into a bedroom where the accused followed and prevented her from leaving the room by physically blocking the door. After a couple of hours, the accused left the residence, and the police were contacted. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Jorge Adalberto **MUNOZ CRUZ**. On November 7, the accused was located and taken into custody by members of the Stafford County Sheriff's Department.

Unlawful Entry | Assault and Battery – On November 7 at 4:50PM, officers responded to a residence located in the 15900 block of Donald Curtis Dr. in Woodbridge (22191) to investigate a burglary. Upon arrival, officers encountered the homeowner who was outside the residence. The homeowner reported to police that when she entered her home, she observed three unknown individuals, two women and one man, inside the residence. When the homeowner confronted the group, the man grabbed her and pushed her outside of the house before closing the door. The investigation revealed that the group entered the home through front door which was found unsecured. The man and one of the women, fled the home prior to police arrival. The man was later located a short distance away and identified as Elijah Amir **HOSKIE**, before being taken into custody. When officers attempted to make contact with the occupants who remained inside the home, they received no answer from inside. Eventually, officers entered the home and located the other woman, identified as Ebony Chantel **HANSON**, in the basement where she was detained. No injuries were reported. A camera was reported missing. Following the investigation, **HOSKIE** and **HANSON**, were arrested. The case will remain active as detectives attempt to locate the third suspect.

Assault and Battery on a Law Enforcement Officer [LEO] – On November 7 at 12:17AM, officers responded to the 14500 block of Jefferson Davis Hwy. in Woodbridge (22191) to investigate an unconscious man who was laying on the ground. Upon arriving in the area, officers observed a man, later identified as the accused, who was unresponsive but breathing and without obvious injuries to his body. Rescue personnel arrived and moved the accused inside to an ambulance. A short time later, the accused regained consciousness and immediately attempted to physically assault rescue personnel, to include attempting to bite them. Officers intervened and, at one point, the accused struck an officer in the chest area before the accused was taken into custody and transported to an area hospital. No injuries were reported. Following the investigation and the accused's release from the hospital, the accused, identified as Felipe Arturo **GAMERO SANDOVAL**, was arrested.

Assault and Battery on a Law Enforcement Officer [LEO] – On November 6 at 7:57PM, officers responded to a residence located in the 3500 block of Briarwood Dr. in Dumfries (22026) for a mental health consumer in crisis. When officers arrived at the residence, a man, later identified as the accused, stood in the doorway, and spoke to the officers. While investigating, officers determined no police action was necessary and were asked to wait while the other occupants of the home prepared to leave. The accused remained in the doorway talking to officers when, without provocation, the accused struck an officer in the head. A struggle ensued and the accused refused to follow officer's commands by actively resisting. At some point, a family member intervened to assist, and officers were eventually able to secure the accused. During the encounter, the accused shoved an officer to the ground. The officers received treatment at an area hospital for minor injuries. Following the investigation, the accused, identified as Rodney Leon **WARD**, was arrested.

Assault and Battery on a Law Enforcement Officer [LEO] – On November 6 at 6:30PM, officers responded to the 10100 block of Lake Jackson Dr. in Manassas (20111) to investigate an unknown man in the caller’s yard. Upon arriving at the home, officers made contact with the man, later identified as the accused, who appeared to be suffering a mental health crisis. Officers transported the accused to a nearby crisis assessment center. While at the center, the accused struck a sheriff’s deputy before actively attempting to assault the officers and flee from their custody. After a brief struggle, the accused was resecured. No injuries were reported by the officer. Following the investigation, the accused, identified as Ronald William **MCFARLAND**, was arrested.
