- Osbourne Park High School's Student Council Association (SCA) will organize the drive to collect gift cards for PIT.

o SCA has at least 4 fundraisers planned between now and December with a goal of 150-200 individual gift cards (more details to come).

Homeless Data Integration Project (HDIP)

• The HDIP policies, procedures, and agreements are still under review by state governance; once these documents are approved, the HDIP committee will move forward with next steps.

Regional Racial Equity Project

- The CoC data request has been submitted to C4 Innovations for analysis.
 - o This data will provide an analysis of racial equity within each participating CoC as well as on a regional level.
