4 penny tax on every dollar (NOT including sales tax, most tips or service charges) on the cost of any

food and beverage item, including alcoholic beverages served as part of a meal, purchased in or from any place where food is served to or prepared for the public (restaurant, caterer, fast food chain, bar, winery, etc.)

> Adopted April 26, 2022 Beginning July 1, 2022

Collected and held, in trust, by the seller until the twentieth of the following month.

Seller retains 3% of the total tax collected to offset the cost of collection, if remitted timely.

Conservatively estimated to raise \$24.5M, over \$14.0M for Prince William County Schools.

Supplemental Nutrition Assistance Program (SNAP) meals are exempt from the tax (complete list of exemptions will be listed on the County's web site).

According to the CDC fast food consumption increases as family income level increases.

Per Placer.ai study there are four food nodes in the County responsible for 8.6M annual restaurant visits nearly half (46.2%) of which are funded by non-County residents:



Also per Placer.ai study the annual Household Income of families eating at these restaurants is \$120K.


The lowest substantial demographic cohort or patron had an annual Household Income of \$75K and was a non-County resident.
