Approval of Minutes

Presentation

Assistant Director for Homeless Services, Tony Turnage, gave the board a presentation on the FY2022 Annual CoC Report Card. The annual report summary and detailed slides were provided as handouts. Tony made his presentation via teleconference.

A robust discussion regarding the lack of permanent supportive housing ensued.

It was also noted that DSS currently receives more calls for rental assistance than for reports of abuse and neglect. The moratorium on evictions, that was put in place during COVID, is ending and is a cause for concern. There has been a spike in evictions due to overdue rent. DSS is currently paying approximately \$100k per month to house displaced residents and this is unsustainable.

Action Items

The Advisory Board asked that letters be sent congratulating staff on their 10-20-30 years of service to the County. [Unanimous consent].
