 - Ms. Bright received a copy of the Report of the Free-Roaming Cat Stakeholder Group dated 17 Jan 2023 she received today in Richmond. Mr. Cleveland provided background that its goal was to bring together all stakeholders and a comprehensive plan that everyone could agree on.

- Educational Opportunities in PWCS

- Monitoring the veterinarian position for the animal shelter as a precursor to following up with the school board on adding the Vet Science Program to the Career and Technical Education (CTE) Programs.
- Dog Licensing 3 year option
 - o No update
- Discussion on Pet Stores and Puppy Mills
 - BOS is pushing back on the Pet Store Resolution, because of VA Code 3.2-6511.1 Pet shops; procurement of dogs; penalty
 - AAC will reach back out to Joyce Fadeley to document a new resolution.
 - From the July 2021 minutes: "Joyce Fadeley, Assistant Director of Planning / Land Development Services Chief
 - Zoning Ordnance- Pet Store retail store selling pets and supplies and limited veterinarian services. SUP required for boarding and kenneling of pets as an accessory to a pet store.
 - Pet Stores are allowed in only the B1, B2, B3 zoning districts
 - The PWC Zoning Ordinance is not a strong ordinance and does not limit number of animals. SUP would be able to put in controls to the Pet Store.
 - Action: BOS will need to direct the Zoning Board to review and provide updates to the Zoning Ordinance.
 - Action: Ms. Shott can contact Ms. Fadeley and request the office run a database search for all pet stores that receive building occupancy in year of 2021."

- Returning to In-Person Meetings: AAC is permitted to have two (2) virtual meetings per year.
- Bylaw Amendment: Mr. Crigger and Ms. Korzuch will work on preparing a tracked changes version of the bylaws for review by the AAC.
- German Shepard at Shelter Topic: The shelter follows State Shelter Veterinarian
 intake procedures. The dog received vaccines IAW the intake procedures. The dog
 was returned to the owner. The dog died twelve days later.
