- Commissioner Jean-Louis Discussed the food insecurity event that was held at Fort Belvoir. Future goals are to hold this event at bases across the United States. Acknowledged that this month is Asian American and Pacific Islander Heritage month and explained the details of this month. Discussed that the American Legion Post 176 is hosting a joint Veteran Services Organization ceremony to honor Vietnam Veterans on Sunday April 9<sup>th</sup> from 1-2p.m.
- Commissioner Gordy Also recognized Military Appreciation month. Let Commissioners know that the board recognized last month as the Month of the Military Child and recognized families with children in Prince William County. Discussed licensing from other states now being able to transfer.
