Residency Policy - clarification on what is considered "vulnerable"

• The previous motion to view non-residency on a case-by-case basis and refer the most vulnerable to a shelter who do not want to return to their jurisdiction. The task was to define "vulnerable." Several committee members weighed in on their definition of vulnerable and who would be the committee members to hear these cases.
