2024 – 2025 Paramedic Program Enrollment Steps

Step 1: Carefully Review Training Advisory

- Carefully review the Training Advisory released by the PSTC. Be sure to meet all deadlines. There are some changes to the 2024 – 2025 program, so please review this announcement completely. Late or incomplete entries **will not** be accepted.

Step 2: Discuss Your Intent with Your Officer

- Embarking on the journey to becoming an ALS provider is challenging and requires support. Take time to discuss your intent with your officer. Once you get approval and support from your officer, please have them send an email to Lt. Cooper (sacooper@pwcgov.org) and your Battalion Chief documenting their endorsement. Endorsement is required.

Step 3: Submit TD-19 and Schedule Your Entrance Exam

- Submit your TD-19.
- There is both a written and practical exam required to enter the program. This ensures that all students have a strong foundational knowledge of BLS. There are three opportunities to complete the entrance exams:

• **Tuesday, May 21, 2024 (A-Shift) | 0800-1200 | PSTC**

• **Wednesday, May 22, 2024 (B-Shift) | 0800-1200 | PSTC**

• **Thursday, May 23, 2024 (C-Shift) | 0800-1200 | PSTC**

Choose the date which best works with your schedule. Please send an email with the subject: **Paramedic Pretest** to Lt. Cooper (sacooper@pwcgov.org) with your requested date and time. If you are on shift that day, please indicate that in the email. A list will be sent by Lt. Cooper to Staffing. Please note, your day may be adjusted due to staffing needs. You will receive a confirmation reply

once your TD-19 and letter of support have been received and your test date has been scheduled. Additional dates will not be offered. Late arrivals to the test will not be admitted.

Step 4: Study Objectives and Practice Skills

- Once you schedule your exam, if requested, you will receive a copy of the Brady, Emergency Care 12th or 13th Edition textbook via county courier. You are encouraged to review the textbook. This book must be returned to the exam proctor at the time of the exam.
- The cognitive exam is a timed, multiple-choice exam. The psychomotor exam is a scenario-based station where you will be required to perform common BLS skills within the context of a typical 911 situation. Please bring your PIC kit to the test.

Step 5: Receive Results

- Once everyone has completed the written and practical examinations, the EMS Training Staff will compile the results. Please expect to receive an email with your results in approximately one week. If you do not receive an email by **June 17, 2024**, please contact Lt. Cooper.

Anatomy and Physiology

This year, the Anatomy & Physiology prerequisite program will be offered online. If you are interested in the program, send an email to Lt. Cooper to request to be enrolled in the program. This course is a pre-requisite for the Paramedic Program.

EMS 3000 (Self-Paced): Online

This 80-hour course is designed to meet the National EMS Education Standards for A&P for those wishing to take the Paramedic class. This class is 100% online

and self-paced. Successful completion of this course is required for entrance into the Paramedic program.
