Updates

Murder Investigation *ARREST – On January 25, 2024, Prince William County police charged the suspect sought in connection to the murder of a 27-year-old man, and the shooting injury of a second man, following an altercation that occurred in the 13900 block of Richmond Hwy. in Woodbridge (22191) on January 16, 2023. Recent results of forensic evidence collected at the scene identified a person of interest believed to be involved in the incident as the suspect. Further investigation revealed the parties were known to one another and the incident is believed to have stemmed from a previous altercation and ongoing dispute between the men. On January 25, 2024, following the investigation, detectives obtained arrest warrants for the suspect, identified as Zaire Lee **DAVIS**, who was served while incarcerated in Fairfax County on unrelated charges. No additional suspects are being sought in connection with the investigation at this time.

**Continuation from the investigative update on the previous page.*

Homicide Investigation [Previously Released] – On January 16 at 8:50PM, officers responded to the 13900 block of Richmond Hwy. in Woodbridge (22191) to investigate a shooting. Once on scene, officers located a 22-year-old man suffering from a gunshot wound to the lower body. Fire and rescue personnel responded and transported the man to an area hospital where his injuries were determined to be non-life threatening. Security officers from a nearby shopping center notified officers of a second man suffering from multiple gunshot wounds. Officers provided first aid to the 27-year-old man until fire and rescue personnel transported the victim to an area hospital where he died from his injuries. The initial investigation revealed a group of individuals were in the above area when gunshots were fired, striking the two men. While investigating the incident, officers were informed, that at the time of the shooting, an occupied vehicle that was driving on Richmond Hwy. near the above area and was also struck by gunfire. No additional injuries were reported. A police K-9 also responded and searched the area, no other involved parties were located. At this time, detectives are actively investigating the incident to determine what led up to the shooting and are seeking to speak with anyone who witnessed the incident or has information as to what occurred. **Preliminarily, the incident does not appear to be random.** The investigation continues.

Shooting into a Residential Dwelling – On January 26 at 4:41PM, officers responded to a residence located in the 1300 block of E. Longview Dr. in Woodbridge (22191) to investigate a shooting. The investigation revealed a resident of the home heard loud noises just before the home was struck with gunfire. No injuries or additional property damage were located.

Residential Burglary – On January 27 at 10:56PM, officers responded to a residence located in the 14700 block of Ducktan Lp. in Gainesville (20155) to investigate a burglary. The investigation revealed sometime between 2:00PM and 10:00PM, entry was forced into the home through a third story window. During a check of the home, a ladder was found leading up to the window. Jewelry and an undisclosed amount of money were reported missing.

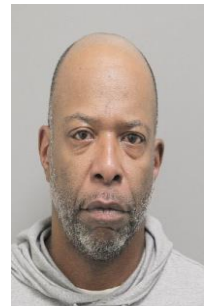

Commercial Burglary – On January 27 at 7:08AM, officers responded to the Crystal Smoke Shop located at 2680 Opitz Blvd. in Woodbridge (22192) to investigate an alarm activation. Video surveillance revealed an unknown man smashed the glass front door with a golf club and entered the business. The suspect took several vape products before fleeing on foot. Officers and a police K-9 searched the area for the suspect who was not located. The suspect was described as a black male wearing a grey fitted cap, a black jacket and pants, and blue socks with black shoes.



Arrests

Shooting Within a Residential Dwelling – On January 28 at 6:49AM, officers responded to a residence located in the 18000 block of Purvis Dr. in Triangle (22026) to investigate a prowler. The investigation revealed the victim, a 25-year-old woman, observed an unknown man, later identified as the accused, outside of her door brandishing a firearm while implying he was law enforcement. When officers arrived in the area, they located the accused walking away from the home in possession of a firearm. Officers took possession of the firearm and detained the accused without incident. Further investigation revealed, the accused fired multiple rounds inside of his nearby home before going to the victim's residence. While investigating the shooting, officers located suspected illegal narcotics, damage to the interior of the home consistent with being struck by gunfire and shell casings. No injuries or additional property damage were reported. Following the investigation, the accused, identified as Patrick Leon **LYNN**, was arrested.

Aggravated Malicious Wounding – On January 26 at 8:16PM, officers responded to a residence located in the 12200 block of Hooe Rd. in Bristow (20136) to investigate an assault. The investigation revealed the victim, a 49-year-old man, and an acquaintance, identified as the accused, were involved in an ongoing dispute that escalated. During the encounter, the accused brandished a knife and stabbed the victim multiple times. The parties eventually separated, and the police were contacted. The victim was treated at an area hospital for serious, non-life threatening injuries. Following the investigation, the accused, identified as Thomas Lee Cornelius **SMITH**, was arrested.

Sexual Assault Investigation – On January 26, detectives concluded an investigation into a sexual assault that was reported to have occurred at a residence in the 11100 block of Wortham Crest Cl. in Manassas (20109) on the afternoon of January 25. The investigation revealed the accused, who was providing transportation for the victim, a 26-year-old woman, drove to a residence in the above area instead of the prearranged destination. While at the residence, the accused and a male acquaintance prevented the victim from leaving the home before sexually assaulting her. The accused later brought the victim to her residence where she reported the incident to a family member who contacted the police. Following the investigation, both of the accused, identified as Angela **OLINGER** and Anthony **GIACCHINA**, were arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On January 26 at 1:11PM, officers responded to the Days Inn located at 7249 New Market Ct. in Manassas (20109) to investigate a trespasser. Officers located the man, later identified as the accused, who was intoxicated and refusing to leave the hotel. While investigating the incident, the accused went outside of the hotel and refused to follow the officer's commands before being taken into custody. While processing the accused at the Adult Detention Center, he kicked an officer before urinating on three officers. No injuries were reported. Following the investigation, additional charges were sought for the accused, identified as Martin O. **AJAY**.
