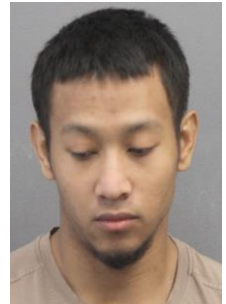
**Strangulation | Domestic Related \*ARREST** – On February 17, the suspect, identified as Kenny **THACH**, who was sought in connection to the domestic assault that was reported to have occurred at an apartment located in the Misty Ridge Apartments located in the 2000 block of Sequoia Ct. in Woodbridge (22191) on February 7, was arrested.

**Strangulation | Domestic Related [Previously Released]** – On February 7 at 11:50AM, officers responded to the Misty Ridge Apartments located in the 2000 block of Sequoia Ct. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 24-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused physically prevented the victim from leaving the room before grabbing her neck. Eventually, the parties separated, and the accused left the apartment. The victim reported minor injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Kenny **THACH**. Attempts to locate the accused have been unsuccessful.

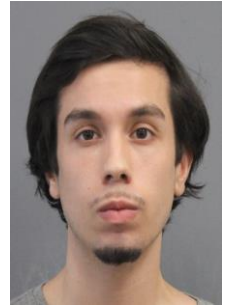
**Abduction \*ARREST** – On February 15, the suspect, identified as Gabriel Anthony **TRIGLIA**, who was sought in connection to the abduction that was reported to have occurred at a residence located in the 8000 block of Community Dr. in Manassas (20109) on January 20, was arrested.

**Abduction [Previously Released]** – On January 20 at 3:47AM, officers responded to a residence located in the 8000 block of Community Dr. in Manassas (20109) to investigate an assault. The investigation revealed the victim, a 20-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim several times and physically prevented the victim from leaving on more than one occasion. The victim was eventually able to leave the apartment and went to an area hospital where police were contacted. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Gabriel Anthony **TRIGLIA**. Attempts to locate the accused have been unsuccessful.

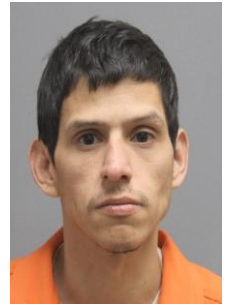

## Incidents

**Residential Burglary** – On February 19 at 12:10PM, officers responded to a residence located in the 2300 block of Marline Ct in Woodbridge (22192) to investigate a burglary. The investigation revealed neighbors observed an unknown man enter the home through a rear sliding door before leaving with a large television. No other property was reported missing.

## Arrests

**Aggravated Malicious Wounding** – On February 19 at 4:19PM, officers responded to the area of Old Bridge Rd and Oakwood Dr in Woodbridge (22192) to investigate a fight. The investigation revealed the victim, a 26-year-old man, was struck multiple times in an unprovoked attack by an unknown man, later identified as the accused, while the two were riding in an Omnibus. The bus stopped in the above area where police were contacted and responded. The accused was determined to be intoxicated and subsequently detained without further incident. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as Deybi Ismael **ESPINOZA**, was arrested.

**Assault & Battery on a Law Enforcement Officer [LEO]** – On February 19 at 10:32AM, officers responded to Croppers Auto Care located at 17662 Main St in Dumfries (22026) to investigate an attempted vehicle theft. The investigation revealed the accused was attempting to steal a vehicle in the parking lot when he was confronted and detained by employees. When officers arrived, the accused initially provided a false identity. Once the identity of the accused became known, it was determined he had active arrest warrants. The accused was transported to an area hospital for an injury sustained prior to police contact. While in custody, the accused kicked an officer in the chest. No injuries were reported. Following the investigation, the accused, identified as Christopher David **LIMING**, was arrested.
