The Emergency Housing Assistance Program, EHAP, II is nearing the end of funding. The application period will re-open for one week to receive applications to expend the remaining funding.

Three non-profit organizations were provided \$1M for the acquisition of Affordable Dwelling Unit(s) to serve beneficiaries in accordance with their agency missions. The three organizations are: Volunteers of America for persons with disabilities; Streetlight Community Outreach Ministries for people experiencing homelessness who are medically fragile; and Insight for persons with developmental disabilities.
