### **Incidents**

**Armed Robbery** – On March 1 at 2:53PM, officers responded to the 4700 block of Korvett Dr. in Woodbridge (22193) to investigate a robbery. The investigation revealed the victim, a 19-year-old man, was approached by an acquaintance, identified as the accused, as he was parked in the above area. During the encounter, the accused brandished a firearm and took the victim's phone, clothing, and money before fleeing. No shots were fired, and no injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Anthony Antonio **WHITE Jr.** Attempts to locate the accused have been unsuccessful.

**Malicious Wounding –** On March 1 at 11:07PM, officers responded to a residence located in the 7500 block of Clemson Ct. in Manassas (20109) to investigate an assault. The investigation revealed the victim, a 24-year-old man, and an unknown man were involved in a verbal altercation that escalated. During the encounter, the other party cut the victim's hands with a machete-style knife before leaving the area with another man in a grey truck. The victim was treated at an area hospital for non-life threatening injuries. The suspect was described as a Hispanic male with black hair.

**Malicious Wounding** - On March 3 at 2:49AM, officers responded to Tandoori Nights located at 14633 Richmond Hwy. in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 44-year-old man, was involved a verbal altercation with group in the parking lot of the business. During the encounter, a man in the group struck the victim causing him to fall to the ground. The parties separated and the suspect fled the area prior to police arriving on scene. The victim was treated at an area hospital for minor injuries. The suspect is described as a male wearing all black clothing.

**Reckless Handling of a Firearm | Destruction of Property -** On March 3 at 4:45PM, officers responded to a residence located in the 3700 block of Del Mar Dr. in Woodbridge (22193) to investigate a destruction of property. The investigation revealed at approximately 7:48PM on March 2, residents of the home heard gunshots before finding damage to a parked vehicle the following day. Officers determined there were no previous reports of gunfire in the area during the above timeframe. No injuries or additional property damage were reported.

**Armed Robbery –** On March 3 at 1:27PM, officers responded to the Starbucks located at 15100 Potomac Town Pl. in Woodbridge (22191) to investigate a robbery. The investigation revealed two men entered the store where one of the men approached the service counter. During the encounter, the suspect implied he had a weapon and demanded money from the register. When the employee did not comply and other patrons began to intervene, the suspect grabbed the tip jar and food items before both suspects fled the store. No injuries were reported, and no weapons were seen.

### **Arrests**
