## **Incidents**

Assault by Mob | Brandishing of a Firearm - On February 12 at 12:45AM, officers responded to a residence located in the 4300 block of Sudley Rd. in Haymarket (20169) to investigate an assault. The investigation revealed a group was involved in an altercation at the residence that escalated. During the encounter one of the victims, a 31-year-old woman, was physically assaulted while a second victim, a 25-year-old man, had a knife held to his neck. A short time later, another individual brandished a firearm and held it to the male victim's head. Eventually, parties separated, and the victims left the residence to a neighbor's home where police were contacted. Minor injuries were reported. Following the investigation, detectives executed a search warrant at the residence where they arrested one of the suspects, identified as Anthony AGUIRRE, who was also found in possession of a firearm and ammunition. Additionally, detectives obtained arrest warrants for two other suspects, identified as Jasmine Denisha GARCIA and Eric Yovany MELARA. Attempts to locate the two wanted suspects have been unsuccessful.

**Reckless Handling of a Firearm –** On March 5 at 8:57PM, officers responded to the 15000 block of Alabama Ave. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed multiple shots were

fired from a red Chevrolet Trailblazer that was seen driving in the area. While checking the area, officers

located two unoccupied vehicles that were hit by the gunfire. No injuries or additional property damage

were reported. This incident does not appear to be random.

Strong-Arm Robbery - On March 5 at 10:07PM, officers responded to the Columbus Grill located at 8349

Centreville Rd. in Manassas (20111) to investigate a robbery. The investigation revealed an employee was approached by an unknown man outside the business as she was taking out trash. During the encounter,

the man struck the victim in the face and took her phone before fleeing. The victim went back into the

business where police were contacted. While checking the area, the victim's phone was located. Minor

injuries were reported. The suspect was described as a tall black male wearing a black hat and all black

clothing.

Arrests

School Threat Investigation - On March 5 at 11:12AM, the School Resource Officer (SRO) assigned to

Hylton High School located at 14051 Spriggs Rd. in Woodbridge (22193), was notified via the BARK Alert

system of a threat made via email towards the school. The investigation revealed a student, later identified

as the accused, sent a bomb threat over email to a school staff member. While investigating the incident, the SRO identified the sender of the messages and determined the threat to the school was not credible.

Following the investigation, the accused, identified as a **15-year-old male student**, was arrested.
