Assault with a Caustic Substance | Animal Cruelty – On February 27 at 7:55AM, Animal Control Officers responded to investigate an assault that was reported to have occurred in the 3900 block of Forestdale Ave. in Woodbridge (22193) on February 26 at approximately 4:30PM. The investigation revealed the accused was walking his dog when he encountered the victim, a 16-year-old male juvenile, and his unleashed dog from a nearby yard. As the two dogs began to interact, the accused pepper-sprayed the victim's dog. After the victim secured his dog, the accused followed them onto the victim's property



where the accused pepper-sprayed the victim and then the dog a second time. Eventually the parties separated. Minor injuries were reported by the victim. The victim's dog, described as a Labrador-Poodle mix, appeared uninjured. Following the investigation, the accused, identified as James Michael **TIMBERLAKE**, was arrested.
