### Incidents

**Shooting Investigation** – On March 7 at 11:57PM, officers responded to investigate a shooting that was reported to have occurred at La Caverna Bar and Grill located at 18033 Dumfries Shopping Plz. in Dumfries (22026) earlier that evening. The investigation revealed the victim, a 29-year-old man, was involved in a verbal altercation with a group of individuals that escalated in the parking lot of the above location. At one point during the altercation, one of the individuals retrieved a firearm and fired a round striking the victim to the upper body. All parties fled prior to police arriving in the area. The victim was treated at an area hospital where police were contacted. The injury was determined to be non-life threatening. No additional injuries or property damage were reported.

***Suspect Description:***

A Hispanic male about 35 years old, approximately 5'8", 150lbs., with black hair, brown eyes, and a full beard and mustache

## Arrests

**Threats to Bomb** – On March 7 at 2:29PM, officers responded to the Hampton Inn located at 16959 Old Stage Rd. in Dumfries (22025) to investigate a threat to the business. The investigation revealed a man, later identified as the accused, was involved in a verbal altercation with an employee in the lobby that escalated. During the encounter, the accused threatened to bomb the hotel before leaving on foot. Responding officers located the accused a short distance away. When officers attempted to detain the accused, he fled. After a short foot pursuit, the accused was detained and found in possession of suspected illegal drugs. No injuries were reported. Following the investigation, the accused, identified as Logan Caldwell **CUNHA**, was arrested.



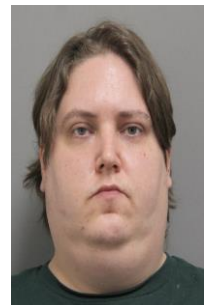

**Assault & Battery on a Law Enforcement Officer [LEO]** – On March 7 at 5:08PM, officers responded to a residence located in the 3700 block of Grey Ghost Ct. in Dumfries (22025) to investigate a domestic dispute. Officers determined a man, later identified as the accused, assaulted two adult family members. When officers attempted to detain the accused, he actively resisted. During the encounter, the accused pushed and then attempted to strike an officer before being taken into custody without further incident. No injuries were reported. Following the investigation, the accused, identified as Chris **MCGINNIS**, was arrested.
