# **DAILY INCIDENT REPORT**

March 11, 2024

## Incidents

**Fatal Crash Investigation** – On March 10 at 3:43AM, crash investigators responded to the intersection of Richmond Hwy. and Easy St. in Woodbridge (22191) to investigate a crash. The investigation revealed the driver of a 2016 Toyota Corolla was traveling southbound on Richmond Hwy. at a high rate of speed. At one point, the driver lost control, crossed over the median into the northbound lanes, and struck a 2023 Chrysler Pacifica. The driver and only occupant of the Corolla, a **17-year-old male juvenile**, was pronounced deceased at the scene. The driver and a passenger in the Pacifica were transported to an area hospital with non-life threatening injuries. Speed is a factor in the collision. Due to the age of deceased, the identity of the driver will not be disclosed by law enforcement. The investigation continues.

#### Identified:

The deceased driver of the 2016 Toyota Corolla was identified as a **17-year-old male juvenile** of Woodbridge

The driver of the 2023 Chrysler Pacifica was identified as a **42-year-old woman** from Manassas The passenger in the 2023 Chrysler Pacifica was identified as a **46-year-old man** from Chantilly

**Shooting into a Residential Dwelling –** On March 9 at 1:38AM, officers responded to the Riverwoods Apartments located in the 2700 block of Dettingen Pl. in Woodbridge (22191) to investigate a shooting. The investigation revealed several gunshots struck the apartment building. One of the shots entered an apartment and grazed a 73-year-old man who was treated at an area hospital for the non-life threatening injury to his upper body. Officers collected bullet fragments from inside the apartment. No additional injuries or property damage were reported.

### Arrests

**Rape Investigation –** On March 8 at 4:49PM, officers responded to investigate a sexual assault that was reported to have occurred at a residence located in the 12200 block of Granada Way in Woodbridge (22192) earlier that day. The investigation revealed the victim, a 27-year-old woman, was sexually assaulted by the accused with whom she had recently met while at his residence in the above area. The victim eventually left the residence and contacted the police. Following the investigation, the accused, identified as Mohd Haroon **HAKIMI**, was arrested.

**Strangulation** | **Domestic Related** – On March 9 at 6:14PM, officers responded to a residence located in the 1500 block of Aiden Rd. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 52-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and grabbed her neck. The parties eventually separated, and the accused fled the residence prior to police arriving at the home. While investigating the incident, officers located the accused who was detained without incident. Minor injuries were reported. Following the investigation, the accused, identified as Alex Francisco AREVALO, was arrested.
