### Updates

**Fatal Hit & Run Crash Investigation \*REWARD –** The Prince Wiliam County Police Department is offering a reward for information leading to the driver and vehicle sought in connection to the fatal hit & run crash that occurred in the area of Minnieville Rd and Bobcat Ct in Woodbridge (22193) on February 24. The crash killed a 27-year-old woman from Woodbridge who was struck while walking along the roadway. During the investigation, investigators located vehicle parts believed to belong to a 2009-2012 Hyundai Santa Fe SUV or 2009-2013 Kia Sorento SUV, silver or light in color, with possible damage to the front end, wheel well, and/or undercarriage areas of the vehicle. Attempts to locate the driver and vehicle involved in the collision have been unsuccessful. **The police department is offering a reward of up to \$5,000 for information that leads to the driver and vehicle involved.** The investigation continues.

### Vehicle Description:

A 2009-2012 Hyundai Santa Fe SUV or 2009-2013 Kia Sorento SUV, silver or light in color, with possible damage to the front, wheel well, and/or undercarriage areas

#### Identified:

The deceased pedestrian was identified as Carla Andrea MEJIA, 27, of Woodbridge

**Fatal Hit & Run Crash Investigation [Previously Released] –** On February 24 at 11:37PM, officers responded to the area of Minnieville Road and Bobcat Court in Woodbridge (22193) to investigate an unconscious female in the roadway. The investigation revealed that the victim, a 27-year-old woman, was walking in the westbound lane of Minnieville Road, wearing all dark clothing, when she was struck by a vehicle. The striking vehicle did not stop at the scene. Fire and rescue personnel responded to the scene where the pedestrian was pronounced deceased. The vehicle is believed to be an unknown model Hyundai. No further information on the driver or striking vehicle is available at this time. **Investigators with the Crash Investigation Unit are asking anyone who may have witnessed this crash to contact police.** The investigation continues.

**Armed Robbery \*ARREST –** On March 11, the suspect, identified as Anthony Antonio **WHITE Jr.**, who was sought in connection to the robbery that was reported to have occurred in the 4700 block of Korvett Dr. in Woodbridge (22193) on March 1, was arrested.

**Armed Robbery [Previously Released] –** On March 1 at 2:53PM, officers responded to the 4700 block of Korvett Dr. in Woodbridge (22193) to investigate a robbery. The investigation revealed the victim, a 19-year-old man, was approached by an acquaintance, identified as the accused, as he was parked in the above area. During the encounter, the accused brandished a firearm and took the victim's phone, clothing, and money before fleeing. No shots were fired, and no injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Anthony Antonio **WHITE Jr.** Attempts to locate the accused have been unsuccessful.
