Assault by Mob | Brandishing of a Firearm *ADDITIONAL ARREST - On March 9, the suspect, identified as Jasmine Denisha GARCIA, who was sought in connection to the assault that was reported to have occurred at a residence located in the 4300 block of Sudley Rd. in Haymarket (20169) on February 12, was arrested. Another suspect was previously arrested in connection to the incident on February 13. Assault by Mob | Brandishing of a Firearm [Previously Released] - On February 12 at 12:45AM, officers responded to a residence located in the 4300 block of Sudley Rd. in Haymarket (20169) to investigate an assault. The investigation revealed a group was involved in an altercation at the residence that escalated. During the encounter one of the victims, a 31-year-old woman, was physically assaulted while a second victim, a 25-year-old man, had a knife held to his neck. A short time later, another individual brandished a firearm and held it to the male victim's head. Eventually, parties separated, and the victims left the residence to a neighbor's home where police were contacted. Minor injuries were reported. Following the investigation, detectives executed a search warrant at the residence where they arrested one of the suspects, identified as Anthony AGUIRRE, who was also found in possession of a firearm and ammunition. Additionally, detectives obtained arrest warrants for two other suspects, identified as Jasmine Denisha GARCIA and Eric Yovany MELARA. Attempts to locate the two wanted suspects have been unsuccessful.

Incidents

Attempted Residential Burglary – On March 12 at 10:29AM, officers responded to a residence located in the 2000 block of Radford Dr. in Woodbridge (22191) to investigate an attempted burglary. The investigation revealed two men exited an older model silver Jeep and approached the residence where they attempted to forcibly enter the home by kicking the door. The suspects did not gain entry into the residence and fled the area in the vehicle. No property was reported missing. No suspect descriptions were provided to police.
