Incidents

Armed Robbery – On March 16 at 10:51PM, officers responded to the CVS located at 2200 Tacketts Mill Dr. in Woodbridge (22192) to investigate a robbery. The investigation revealed an unknown man approached the service counter and brandished a firearm before demanding money. The suspect took an undisclosed amount of money and fled on foot. No injuries were reported. A police K-9 searched the area for the suspect who was not located.

Suspect Description:

A black male last seen wearing a black fitted cap, a white/blue face mask, a white North Face jacket, black sweatpants, and black shoes

Malicious Wounding – On March 17 at 4:41PM, officers responded to the Red Carpet Inn located at 17005 Dumfries Rd. in Dumfries (22025) to investigate an assault. The investigation revealed the victim, a 22-year-old man, and a group of men were involved in a verbal altercation that escalated. During the encounter, the victim was struck multiple times before eventually leaving the hotel room and flagging down a nearby officer. The victim was treated at an area hospital for non-life threatening injuries. **This incident does not appear to be random.**

Reckless Handling of a Firearm – On March 17 at 3:36PM, officers responded to the area of Pinetree Dr. and Forest Glen Rd. in Woodbridge (22192) to investigate a shots fired call. The investigation revealed at approximately 1:15PM the driver of a grey Toyota Rav 4 fired multiple rounds into the air from the vehicle. No injuries or property damage were reported. While checking the area, officers located shell casings in the roadway.

Reckless Handling of a Firearm – On March 16 at 10:00PM, officers responded to the 15700 block of Forest Park Dr. in Woodbridge (22193) to investigate a shots fired call. Officers checked the area and were unable to locate evidence of shots being fired. The following day, multiple shell casings were located on a path near the high school. No injuries or property damage were reported.

Commercial Burglary – On March 16 at 5:26AM, officers responded to the Sunoco located at 14501 Gideon Dr. in Woodbridge (22192) to investigate a burglary. The investigation revealed a rock was used to force entry into the business through the glass front door. No property was reported missing.

The investigation revealed sometime between 12:30PM and 4:30PM, entry was forced into the home through the back door. Jewelry and an undisclosed amount of money were reported missing.

The investigation revealed the victim, a 14-year-old male juvenile, was approached by an acquaintance, identified as the accused, who took the victim's face mask. When the victim attempted to follow the accused, he brandished a knife toward the victim before fleeing on foot. While checking the area, officers located and detained the accused without incident. No injuries were reported. Following the investigation, the accused, identified as a **17-year-old male juvenile**, was arrested.

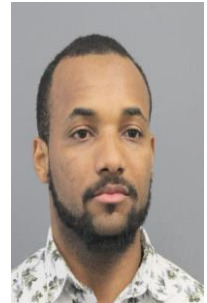

Suffocation | Domestic Related – On March 15 at 4:59PM, officers responded to a residence located in the 10600 block of Sheffield Glen Ln. in Manassas (20110) to investigate a domestic dispute. The investigation revealed the victim, a 31-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter the accused pushed the victim down and got on top of her, restricting her breathing. The victim was eventually able to separate from the accused and left the residence. Minor injuries were reported. Following the investigation, the accused, identified as Ramapoza **ODWYER**, was arrested.

The investigation revealed the victim, an 11-year-old girl, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim multiple times with a metal broom before separating. The victim reported the injuries the following day to school personnel who contacted the police. Minor injuries were reported. Following the investigation, the accused, identified as Marta **VILLANUEVA BENITEZ**, was arrested.
