Incidents

Felony Hit & Run | Maiming while DUI Investigation – On March 12 at 7:55PM, officers responded to the area of Coverstone Dr. and Aaron Ln. in Manassas (20109) to investigate a crash involving a pedestrian. The investigation revealed the driver of a 2012 Nissan Pathfinder, later identified as the accused, was turning left from Coverstone Dr. onto Aaron Ln. when the vehicle struck an 82-year-old man who was attempting to cross the roadway within the intersection. The pedestrian was transported to an area hospital with serious, non-life threatening injuries. The accused fled from the initial scene before striking a 2013 Toyota Camry in the area of Sudley Manor Dr. and Williamson Blvd. The accused then fled on foot before being located a short distance away and detained without incident. The accused and two occupants in the Camry were transported to an area hospital for non-life threatening injuries. On March 18, following the investigation, officers obtained arrest warrants for the accused, identified as Miguel Angel **URQUILLA CORDOVA**. The accused was released from the hospital prior to warrant service. Attempts to locate the accused have been unsuccessful.

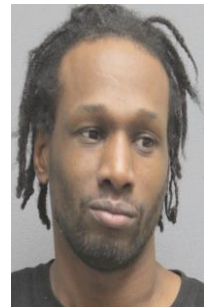

Commercial Burglary – On March 20 at 5:14AM, officers responded to the Sunoco located at 14501 Gideon Dr. in Woodbridge (22192) to investigate a burglary. The investigation revealed a rock was used to force entry into the business through the glass front door. A police K-9 searched the area for the suspect(s) who were not located. Vape products and lighters were reported missing.

Arrests

Abduction | Domestic Related – On March 18 at 4:50PM, officers responded to the Elevations One Apartments located in the 14300 block of Jeffries Rd. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 40-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and physically prevented her from leaving the room. Eventually, the parties separated, and the accused left the apartment. While officers were investigating the incident, the accused returned to the area. When officers attempted to detain the accused, he actively resisted and fled into the apartment where he was detained without further incident. Minor injuries were reported. Following the investigation, the accused, identified as Eric Lynn **MCNEIL**, was arrested.
