Incidents

Homicide Investigation – On March 23 at 2:08AM, officers responded to Club Tempo located at 17650 Possum Point Rd in the Town of Dumfries (22026) to investigate a shooting. The investigation revealed a fight had occurred in front of the location where officers located a 38-year-old man suffering from gunshot wounds. Officers provided first aid to the man who was transported to an area hospital and later died from his injuries. Two vehicles in the parking lot were also struck by gunfire. No other injuries were reported. No suspects have been located at this time. Detectives are actively investigating the incident to determine what led up to the shooting and are seeking to speak with anyone who witnessed the incident or has information to aid in the investigation. **Preliminarily, the incident does not appear to be random.** The investigation continues.

The deceased was identified as Carvell Jarmain **WILLIAMS**, 38, of Warrenton, VA

Armed Robbery – On March 22 at 11:30PM, officers responded to Walgreens located at 10671 Sudley Manor Dr in Manassas (20109) to investigate a robbery. The investigation revealed an employee was approached by an unknown man who brandished a handgun and escorted the employee to a rear office. The suspect took an undisclosed amount of money before fleeing the business with a second man who appeared to be distracting another employee at the front counter. No injuries were reported. A police K-9 searched the area for the suspects who were not located. Both men were described as black males wearing surgical masks. One of the men was wearing a white or gray sweater, dark-colored jeans, and dark-colored shoes while the second man was wearing a gray hooded sweatshirt with dark-colored pants and shoes.

Attempted Armed Robbery – On March 22 at 3:11PM, officers responded to the 8300 block of Sudley Rd in Manassas (20109) to investigate a robbery. The investigation revealed the victim, a 21-year-old man, was approached in the wooded area near the above location and grabbed from behind by an unknown man. During the encounter, a second man displayed a knife and attempted to take the victim's cell phone and wallet. The men were unable to take the victim's property before fleeing on foot. No injuries were reported.

Arrests

Murder Investigation – On March 21 at 8:49PM, officers responded to a residence located in the 12200 block of Stevenson Ct in Woodbridge (22192) to investigate a missing person. The investigation revealed family members were concerned over the welfare of the victim, a 30-year-old woman, who had not picked up her child from daycare. During the investigation, detectives learned the victim's vehicle was being driven by an acquaintance of the victim, later identified as the accused, in Newport News City located in the Hampton Roads area of Virginia, and that the victim's personal belongings were still inside her Woodbridge residence. On March 22, while in the area of the victim's residence continuing the investigation into the victim's whereabouts, detectives stopped and secured a trash collection truck where the victim's body was later located. Additional evidence was discovered which indicated the accused was involved in the victim's death. Following the investigation, detectives obtained a murder warrant for the accused, identified as Brendon Devon **WHITE**, who was located and arrested by Newport News police.

Aggravated Malicious Wounding (Domestic) – On March 23 at 5:59AM, officers responded to a residence located in the 13700 block of Greenwood Dr in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the victim, a 40-year-old woman, and a family member, identified as the accused, were involved in an altercation that escalated. During the encounter, the accused stabbed the victim multiple times with a knife. When other occupants of the home intervened, the accused fled the home. A 7-year-old boy was present during the altercation and was unharmed. Responding officers located the accused near the home where he was detained without incident. The victim was treated at an area hospital with serious injuries. Following the investigation, the accused, identified as Juan Ernesto **VELIT CHICOMA**, was arrested.

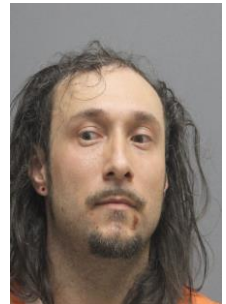

Aggravated Malicious Wounding (Domestic) | Assault & Battery on a Law Enforcement Officer [LEO]

– On March 22 at 11:14PM, officers responded to a residence located in the 14300 block of North Park Ct in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the accused was under the influence of an unknown narcotic and acting aggressively while swinging two knives. During the encounter, the victim, a 58-year-old family member, attempted to help calm the accused when she sustained a severe arm laceration. The accused fled the home as police were arriving on the scene. The accused continued running back and forth into traffic on Minnieville Rd before losing his balance and being detained. During the arrest, the accused struck an officer. The victim was treated at an area hospital for the non-life threatening arm injury. Following the investigation, the accused, identified as Atriom **RASMUSSEN**, was arrested.

Attempted Malicious Wounding (Domestic) – On March 22 at 10:57PM, officers responded to a residence located in the 10400 block of Copeland Dr in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 38-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused threatened the victim with a knife before the parties separated. The accused sustained minor injuries from breaking a window before police arrived on the scene. The victim was not injured. Following the investigation, the accused, identified as Jose Armando **MACHADO DIAZ**, was arrested.

Attempted Malicious Wounding (Domestic) – On March 22 at 9:27AM, officers responded to a residence located in the 15700 block of John Diskin Cir in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 55-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused threatened the victim with a pair of scissors before taking the victim's purse and keys and fleeing the home. Responding officers located the accused near Neabsco Regional Park where he was detained without incident. No injuries were reported. The accused was also found to have possessed a stolen firearm. Following the investigation, the accused, identified as a **16-year-old male juvenile**, was arrested.

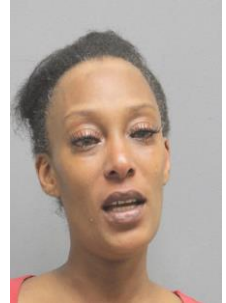

Assault & Battery on a Law Enforcement Officer [LEO] – On March 24 at 11:47PM, officers responded to the area of Olde Port Ln and Graham Park Rd in Triangle (22172) to investigate a crash. During the investigation, a passenger in one of the vehicles, later identified as the accused, exited the vehicle and began to interfere with the officer's investigation. The accused was subsequently detained for public intoxication. While in custody, the accused kicked an officer. No injuries were reported. Following the investigation, the accused, identified as April Joy **HUBBARD**, was arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On March 23 at 2:08PM, officers responded to the 17600 block of Possum Point Rd in Dumfries (22026) to investigate a shooting (see homicide investigation above). While officers were attempting to render aid to the victim, an acquaintance, later identified as the accused, began to interfere. When officers attempted to guide the accused away so officers could continue life-saving efforts, the accused struck an officer in the arm and attempted to strike the officer a second time. Officers escorted the accused to a police cruiser where he then kicked and shattered the window before attempting to climb out of the vehicle. The accused continued to resist until being restrained. No injuries were reported. Following the investigation, the accused, identified as Colby D. **BAILEY**.
