




## DAILY INCIDENT REPORT

March 26, 2024

### Updates

**Murder Investigation \*SUSPECT IDENTIFIED** – On March 24, detectives identified the suspect sought in connection to the fatal shooting that was reported to have occurred at Club Tempo located at 17650 Possum Point Rd in the Town of Dumfries (22026) on March 23. While investigating the incident, detectives identified the suspect as Jonathan Montile **MIDDLETON** and obtained arrest warrants. Preliminarily, the investigation revealed the two parties were known to one another and that the accused and victim were possibly involved in an altercation in the parking lot when the victim was fatally shot. Attempts to locate the accused were unsuccessful. Detectives are continuing to actively investigate the incident and ask anyone who has information regarding this case or the whereabouts of the accused to contact police. The investigation continues.

**Homicide Investigation [Previously Released]** – On March 23 at 2:08AM, officers responded to Club Tempo located at 17650 Possum Point Rd in the Town of Dumfries (22026) to investigate a shooting. The investigation revealed a fight had occurred in front of the location where officers located a 38-year-old man suffering from gunshot wounds. Officers provided first aid to the man who was transported to an area hospital and later died from his injuries. Two vehicles in the parking lot were also struck by gunfire. No other injuries were reported. No suspects have been located at this time. Detectives are actively investigating the incident to determine what led up to the shooting and are seeking to speak with anyone who witnessed the incident or has information to aid in the investigation. **Preliminarily, the incident does not appear to be random.** The investigation continues.

## Incidents

**Aggravated Assault** – On March 25 at 9:11AM, officers began an investigation into an assault that was reported to have occurred in the 8300 block of Sudley Rd in Manassas (20109) on March 20. While investigating an unrelated incident, officers learned sometime during the evening hours of March 22, the victim, a 39-year-old man, was reportedly stabbed by an unknown man, possibly related to a previous incident involving the victim. No additional information was provided to the police, and the victim refused to cooperate further. The victim reported a laceration to his arm from the incident. No suspect information was provided by the victim.

**Attempted Malicious Wounding (Domestic)** – On March 24 at 5:37PM, officers responded to investigate a domestic dispute that was reported to have occurred at the Bayvue Apartments located in the 1300 block of East Longview Dr in Woodbridge (22191) earlier that afternoon. The investigation revealed the victim, a 31-year-old man, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused retrieved a knife leading to a struggle before both parties fell to the floor. When the accused retrieved a larger knife, the victim left the apartment. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Sartisha Elexus **CARTER**, who remains wanted.

## Arrests

**Felony Child Neglect** – On March 25 at 11:34PM, officers responded to a residence located in the 7400 block of Barbados Ln in Manassas (20109) to investigate a child neglect. The investigation revealed the caller contacted police to report a 4-year-old child possibly left unattended at a neighboring residence. Officers arrived at the home and located the child at the front door. The home was checked, and no guardian was located. Upon checking the area, the child's father, identified as the accused, was located intoxicated and sleeping under a tree in an adjacent row of homes. The child was not injured. Following the investigation, the accused, identified as Bryan Andrew **TAYLOR**, was arrested.

**Armed Robbery** – On March 25 at 10:47PM, officers responded to the Klebers Restaurant located at 13634 Richmond Hwy in Woodridge (22191) to investigate a robbery. The investigation revealed a patron, later identified as the accused, brandished a firearm and demanded a beer from the bartender. Police were contacted and the accused was detained on scene without incident where he was determined to be intoxicated. No injuries were reported. Following the investigation, the accused, identified as Dennis Anebar **SALAS FLORES**, was arrested.



## Arrests, *continued*

**Assault & Battery on a Law Enforcement Officer [LEO]** – On March 25 at 10:46PM, officers responded to the 7-Eleven located at 13990 Richmond Hwy in Woodbridge (22191) to investigate a trespassing. The investigation revealed the accused was trespassing on the property and refused to leave. The accused was subsequently detained by police where suspected illegal narcotics were found in his possession. At one point, the accused struggled and assaulted two officers before additional officers arrived and detained the accused. The accused was treated at an area hospital for signs of narcotic use. One officer reported minor injuries. Following the investigation, the accused, identified as Francisco Antonio **PENA BELTRAN**, was arrested.

**Commercial Burglary** – On March 22 at 1:32AM, officers responded to the Crystal Smoke Shop located at 2680 Opitz Blvd in Woodbridge (22192) to investigate an alarm activation. Upon arriving at the business, two individuals immediately fled on foot. After a short foot pursuit, both individuals, identified as the two accused, were detained without further incident. Both accused were identified as **12-year-old male juveniles** and were found in possession of vape products taken from the store. The investigation revealed the suspects threw a rock, shattering the front glass door before entering the business. Following the investigation, both juveniles were arrested.
