Malicious Wounding | Shooting into a Residential Dwelling - On April 7 at 12:51PM, officers responded to The Landings at Markhams Grant Apartments located in the 15700 block of Tassia Ln. in Woodbridge (22191) for a shooting. Responding officers provided first aid to a 16-year-old male juvenile who was found suffering from gunshot wounds. The juvenile was treated at an area hospital for non-life threatening injuries. The investigation revealed several shots were fired before multiple suspects were seen fleeing on foot. The gunshots struck the victim, a nearby community center, and an apartment located on Penbury Ct. While checking the area, officers also located a firearm on Norris Point Way. No additional injuries or property damage were reported.

Threats to Bomb – On April 6 at 6:18PM, officers responded to two separate Planet Fitness gyms located at 14431 Richmond Hwy in Woodbridge (22191) and 12627 Galveston Ct. in Manassas (20112) to investigate a bomb threat made towards the businesses. The investigation revealed the threat was received via email. Officers and police K-9 responded to both locations where the businesses and nearby shopping centers were evacuated as a precaution. No devices were located, and officers determined there was no active threat to businesses. The sender of the threats was not identified.

The investigation revealed the victim, a 36-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim several times. At one point, a 39-year-old family member intervened, and was struck with a baseball bat by the accused before he retrieved a firearm. The accused then struck the female victim with the firearm before preventing
