Incidents

Reckless Handling of a Firearm – On April 10 at 12:25PM, officers responded to investigate a shots fired call that was reported to have occurred in the cul-de-sac of Coppermine Rd. in Manassas (20109) between 9:45PM on April 9 and 6:00AM on April 10. The investigation revealed multiple gunshots were heard at that time. Police were not contacted at the time the shots were heard. The next day, the caller found shell casings in the roadway and eventually contacted police. No injuries or additional property damage were reported.

Vandalism – On April 10 at 8:30AM, officers responded to investigate a vandalism that was reported to have occurred at a construction site located in the 11500 block of Hayden Rd. in Manassas (20109) sometime between January 27 and April 9. The investigation revealed sometime during the above timeframe someone attempted to draw a swastika symbol on one of the steel support beams. The image did not appear to cause permanent damage or contain any threats. Management was notified to remove the image. No additional markings have been reported.

Arrests

Sexual Assault Investigation – On March 31 at 9:28AM, officers responded to the Hampton Inn located at 16959 Old Stage Rd. in Dumfries (22025) to investigate a sexual assault. The investigation revealed the female victim, who was under the age of 15, was sexually assaulted inside the elevator by an unknown man, later identified as the accused. The victim quickly left the elevator and reported the incident to a family member who contacted the police. Following the investigation, officers obtained an arrest warrant for the accused, identified as Dennis James **SCHETTINO.** On April 11, the accused was arrested in Brunswick County, North Carolina where he will remain until extradited to Prince William County.

Use of Communications Systems to Facilitate Certain Offenses Involving Minors – On April 9, 2024, detectives concluded an investigation into the solicitation of a minor that was reported to have occurred in the Woodbridge (22193) area of Prince William County in February 2023. The investigation revealed during the above timeframe, the victim, who was under the age of 18 at the time of the offenses, received sexually explicit messages from an acquaintance, identified as the accused, via text messages. A family member later found the messages and contacted the police. Following the investigation, detectives obtained arrest warrants for the accused, identified as Lamar Bobby **HOPKINS.** On March



25, the accused was served while incarcerated in Prince George's County on an unrelated matter. The accused was extradited to Prince William County on April 9.
