### Incidents

**Commercial Burglary –** On April 17 at 4:45AM, officers located an unsecured door at Wings Ways located at 17173 Wayside Dr. in Dumfries (22026) while conducting a routine business check. Video surveillance revealed around 1:30AM, three unknown individuals forced entry into the business through the rear door. A police K-9 searched the area for the suspects who were not located. An undisclosed amount of money was reported missing.

#### Suspect Descriptions:

The first individual last seen wearing a mask, a blue hooded sweatshirt, black pants, a different style glove on each hand, black shoes and carrying a crowbar

The second individual was last seen wearing a mask, a black hooded sweatshirt with writing, darkcolored pants, black shoes, and also carrying a crowbar

The third individual is described as heavy set and last seen wearing a mask, a black hooded sweatshirt, gloves, and black pants

### Arrests

**Animal Cruelty Investigation** – On April 14, Animal Control Officers concluded an investigation into animal cruelty that was reported to have occurred at the Riverside Station Apartments located in the 14000 block of Big Crest Ln. in Woodbridge (22191) on January 25. The investigation revealed the resident of an apartment, identified as the accused, left several animals, including reptiles and domesticated animals, inside the apartment after moving out. Animal Control Officers located both deceased and live animals which were recovered. The surviving animals were treated and are expected to survive. The treatment of the living animals and the necropsies of the deceased reptiles

revealed the animals had not received proper care for an extended amount of time. Following the investigation, the accused, identified as Paul Michael **BALLETTO**, was charged.

**Sexual Assault Investigation –** On April 13, detectives concluded an investigation into a sexual assault that was reported to have occurred in the 15800 block of Richmond Hwy. in Woodbridge (22191) on the evening of March 12. The investigation revealed the victim, a 28-year-old woman, was approached and inappropriately touched by an unknown man, later identified as the accused. The two parties then walked to a nearby business where the accused sexually assaulted the victim a second time before separating. While investigating the incident, detectives obtained arrest warrants for the accused, identified as Robert Eugene **DEAL**, who was taken into custody by Manassas City police on April 13.

**Contributing to the Delinquency of a Minor –** On April 13 at 8:13PM, officers responded to the Walmart located at 14000 Worth Ave. in Woodbridge (22192) to investigate an unattended child. The investigation revealed a good Samaritan observed the victim, a two-month-old infant boy, unattended inside a vehicle in the parking lot. Upon arriving at the scene, officers observed the parents with the victim who had been taken out of the vehicle. Officers determined the father, identified as the accused, and other family members went into the store, leaving the victim inside the vehicle. The victim was unharmed. Following the investigation, the accused, identified as Mirwais **ALIZADA**, was arrested.
