Incidents

Aggravated Assault – On April 14 at 7:57PM, officers responded to the area of Delaware Dr and Lost Canyon Ct in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 13-year-old male juvenile, was involved in a fight with a group of teen acquaintances. The victim sustained injuries and refused treatment. **The incident was not random** and officers are following up on the suspect's identities for potential charges. The investigation continues.

Reckless Handling of a Firearm | Property Damage - On April 17 at 4:55PM, officers responded to a residence located in the 13600 block of Fitzwater Dr in Nokesville (20181) to investigate a destruction of property. The homeowner reported to the police sometime overnight their vehicle was struck by a bullet. No gunfire had been reported to police during the timeframe and no injuries or other property damage were reported.

Vandalism - On April 16 at 2:30PM, officers responded to investigate a vandalism that was reported to have occurred at a residence located in the 1600 block of Mount High St in Woodbridge (22192) on April 13 at approximately 5:00AM. The investigation revealed the homeowner's American flag and a separate flag depicting the Star of David were removed along with their poles by an unknown individual who was seen walking up to the residence on surveillance footage around that time. The flags and poles were found damaged nearby, the flags torn and poles broken in half. No additional property damage was reported. A similar incident occurred at the same residence in December 2023 when the homeowner's previous Star of David flag was reported stolen.
