1 Finances

From the county financial reports, we have spent \$1925 of our allocation of \$62,784 for costs associated with Arts Alive.

Attached is the latest budget document.

2 Technical Assistance Grants

There is one TA grant application.

Virginia National Ballet would like to purchase two Square Reader Point of Sale Devices with docks and two concession racks to display food at the concession tables.

Concession sales are an important aspect of Virginia National Ballet's performances. The audience members expect to be able to purchase a great selection of food and drink items during the intermissions, and to have a smooth and quick transaction. The new Square tap point of sale devices eliminate the need for swiping cards and thereby reduce the amount of time needed for the transactions. Having two point of sales available will allow two separate lines for credit card sales, rather than one long line.

Having products placed on professional food racks will also make the items more visible so people can choose and take their items quickly. This helps the audience members. The more items we are able to sell, the better it is for Virginia National Ballet, as concession sales are an important source of revenue during the performances.

. The items will help provide a seamless, quick, and professional concession experience before, during, and after the performances, and the increased sales will benefit Virginia National Ballet.
