*Every year in May, law professionals across the country commemorate Law Day to promote an understanding of the legal profession and the importance of law in society. This year, we explore the role of individuals in the Constitution, which begins with the preamble, "We the People, in Order to Form a More Perfect Union." This suggests that our government's structure unites citizens as "one," bridging differences and bringing them together as a nation.*

*This year (2025), the Clerk of Circuit Court is calling for student artwork that reflects the American Bar Association’s Law Day Theme: “The Constitution’s Promise: Out of Many, One.” The goal for the Clerk’s Law Day Art Contest is to provide an exciting and educational way for students to deepen their understanding of the Constitution within this theme while also encouraging civil discourse about the common good and the framework of our democracy.*

*The Clerk of Circuit Court encourages all students in grades 1st-12th enrolled in private, home, and public schools in Prince William County, and the Cities of Manassas and Manassas Park, to submit artwork illustrating the theme “The Constitution’s Promise: Out of Many, One.”*

### **Clerk’s 5th Annual Law Day Artwork Contest**

The Circuit Court Clerk’s 5th Annual Law Day Art Contest offers an exciting and educational opportunity for local students in grades 1 through 12 to participate in Law Day and potentially earn awards.

### **Contest Eligibility**

The contest is open to all local students enrolled for the 2024–2025 school year in grades 1 through 12 in Prince William County, as well as the Cities of Manassas and Manassas Park.

### **Contest Timetable**

- **February 20, 2025:** Public Announcement: Circuit Court Clerk Calls for Law Day Artwork
- **April 23, 2025:** Entries are due by or before April 23 (deadline extended).
- **April 25 – April 28, 2025:** Public Voting opens, both in person and online. Link:
- **April 29, 2025 – May 2, 2025:** Artwork will be on display at the courthouse.
- **May 1:** Law Day Ceremony
- **May 10 – June 8:** Artwork will be on exhibit at Manassas Museum

Artwork will be on display and awards will be presented at the Circuit Court Clerk’s Law Day Ceremony/Open House. Invitations will be sent in advance with details.

### **Art Contest Guidelines:**

- The contest is open to all students in grades 1st through 12th within Prince William County, the City of Manassas, and the City of Manassas Park.
- Artwork submissions can include drawings, photographs, paintings, or other flat artwork inspired by this year's theme: *The Constitution’s Promise: Out of Many, One*.
- All paper and photograph artwork must be matted with a frame. (Standard matted frames are acceptable.)
- Canvases are preferred and easier for exhibiting artwork.
- All entries must include a completed and legible submission form with a brief description of the artwork (form included in packet).
- Top prize winners will receive monetary rewards and other gifts donated by community sponsors.
- All entries will be featured on our social media pages: @PWCCircuitCourt.
- Votes will be taken by the public, digitally and at the courthouse. (Link to be provided.)
- Final winners will be selected and announced at the Clerk’s Law Day Art Ceremony on May 1 at 6:00 p.m.
- Please mail or drop off entries to the Circuit Court Clerk’s Office (9311 Lee Avenue, Room #306, Manassas, VA 20110) no later than 4:30 p.m. on Wednesday, April 23, 2025.
