Incidents

Armed Robbery – On April 5 at 7:24PM, officers responded to the Tackett's Mill shopping center located in the 2200 block of Tacketts Mill Dr in Woodbridge (22192) to investigate a robbery. The investigation revealed the victim, a 14-year-old male juvenile, was approached and robbed at gunpoint by three unknown men. The suspects took the victim's shoes and other clothing items and electronics before leaving the area in a white Acura sedan. No injuries were reported. The suspects were only described as one white male and two black males, all reported to be in their late teens wearing dark-colored clothing and masks.

Reckless Handling of a Firearm – On April 6 at 9:41PM, officers responded to the area of Porters Inn Dr and River Ridge Blvd in Dumfries (22026) to investigate a shots fired call. The investigation revealed multiple shots were heard near a wooded area. Shell casings were located. No injuries or property damage were reported.

Commercial Burglaries – On April 7 at 1:56AM, officers responded to the Dillingham Square shopping center located in the 12500 block of Dillingham Sq in Woodbridge (22192) to investigate a burglary. The investigation revealed two businesses, Pizza Hut and Chili On Top, were found with shattered front glass doors. No property was immediately reported missing. Officers and a police K-9 searched the area for the parties involved who were not located. Another burglary in the same shopping center was reported on April 4 at approximately 2:39AM. The investigation revealed a suspect had entered Concept Nails through the front glass door which had been shattered. A cash register was reported missing. It is unknown if the same suspect(s) were involved in the burglaries.

Residential Burglary – On April 5 at 3:43AM, officers responded to the Rosemary Ridge Apartments located in the 10900 block of Wild Ginger Cir in Manassas (20109) to investigate a burglary. The investigation revealed the entry was made into the apartment through a sliding glass door sometime between 11:00AM on April 4 and 12:40AM on April 5. There were no signs of forced entry into the residence. No property was reported missing.



Commercial Burglary – On April 4 at 9:17AM, officers responded to the Public Storage located at 1365 Old Bridge Rd in Woodbridge (22192) to investigate a burglary. The investigation revealed a storage unit was broken into sometime between March 28 and April 4. Tools and other property were reported missing. No other units appeared to have been burglarized.

Malicious Wounding [Domestic] – On April 6 at 1:36PM, officers responded to a residence located in the 8000 block of Community Dr in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 43-year-old man, and a family member, identified as the accused, were involved in a physical altercation. During the encounter, the accused retrieved a knife and began swinging it towards the victim, making contact with the victim's hand causing a severe laceration. The parties separated and the police were contacted. Following the investigation, the accused, identified as Tiffany Michelle **WYATT**, was arrested.



Abduction | Brandishing [Domestic] – On April 4 at 7:23PM, officers responded to investigate a domestic assault that was reported to have occurred at a residence located in the 3000 block of Vidalia Ct in Dumfries (22026) earlier that morning at approximately 11:30AM. The investigation revealed the victim, a 19-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused brandished a firearm and held the victim to the ground. At one point, the accused bit the victim before the parties separated. Minor injuries were reported. Following the investigation, the accused, identified as Kevin **JENKINS**, was arrested.

The investigation revealed two occupants, including the accused, refused to leave their room after checkout. Officers made contact with the two occupants who continued their refusal. After being taken into custody, the accused spat on an officer and had previously spat on a hotel employee. No injuries were reported. Following the investigation, the accused, identified as Yamilet Cassandra **GLEN**, was arrested. The other occupant, a 25-year-old man, was also charged with obstruction.
