### Incidents

**Commercial Burglary –** On April 8 at 4:45AM, officers responded to the Moma Rosa Pupuseria located at 7237 Centreville Rd in Manassas (20111) to investigate a burglary. The investigation revealed sometime between 5:00PM on April 7 and 4:00AM on April 8, forced entry was made into the business through a rear door. An undisclosed amount of money was reported missing.

The investigation revealed the victim, a 31-year-old man, was approached by an acquaintance, identified as the accused, who brandished a knife and demanded the victim's property. The suspect took an undisclosed amount of money from the victim before leaving the area. No injuries were reported. Officers located the accused nearby where he was detained without further incident.
