**Strangulation [Domestic] \*ARREST** -- On April 9, the suspect, identified as Micah Emmanuel **RAGIN**, sought in connection to the strangulation that was reported to have occurred at the Coverstone Apartments, located in the 7600 block of Cass Pl. in Manassas (20109) on March 29, was arrested. The accused was taken into custody in Manassas by the U.S. Marshal's Fugitive Task Force.

**Strangulation [Domestic] [Previously Released]** – On March 29 at 10:10PM, officers responded to the Coverstone IV Apartments located in the 7600 block of Cass Pl. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 27-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim and threw her to the ground before grabbing her neck. At one point, the accused retrieved a knife and threatened the victim. The parties separated, and the victim contacted the police. Non-life threatening injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Micah Emmanuel **RAGIN**. Attempts to locate the accused have been unsuccessful.

## Incidents

**Malicious Wounding** – On April 9 at 1:28PM, officers responded to investigate a domestic dispute that was reported to have occurred at the Regency Apartments located at the 9000 block of Gardenia Lane in Manassas (20109) on April 8 at approximately 10:30PM. The investigation revealed the victim, 41-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim in the head with a book multiple times before the parties separated. The victim was treated at an area hospital with non-life threatening injuries where the police were contacted. Following the investigation, officers obtained an arrest warrant for the accused, identified as Patrick Michael **Foreman**. Attempts to locate the accused have been unsuccessful.

**Strangulation** – On April 8 at 10:04PM, officers responded to the Wyndham Pointe Apartments located in the 16600 block of Hardwood Oaks Ct in Dumfries (22026) to investigate a dispute. The investigation revealed the victim, a 19-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused assaulted the victim and wrapped his arm around her neck. The parties separated and the police were contacted. No injuries were reported. Following the investigation, the accused, identified as Jose Antonio Munoz **Garcia**, was arrested.
