# **DAILY INCIDENT REPORT**

April 14, 2025

### Incidents

**Aggravated Assault –** On April 13 at 1:06AM, officers responded to Babylon Café located at 3081 Golansky Blvd in Woodbridge (22192) to investigate a shooting. The investigation revealed a fight had occurred in the parking lot resulting in shots being fired. Officers located a 42-year-old man with non-life threatening injuries sustained from the physical altercation. While on scene, a second man, 41-years-old, arrived at an area hospital with a non-life threatening gunshot wound to his arm. Both men were uncooperative with police regarding the suspect(s) involved and what led up to the altercation and subsequent shooting. Several vehicles and the business were struck by gunfire. No other injuries were reported. The suspect was described as a black male wearing a white t-shirt and operating a Harley-style motorcycle.

**Aggravated Assault –** On April 12 at 2:40AM, officers responded to the 13600 block of Richmond Hwy in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 24-year-old man, and an unknown man were involved in an altercation in a parking lot in the above area. During the encounter, the suspect brandished a pocketknife and cut the victim to his hand. The suspect then slashed two tires on the victim's vehicle before the parties separated. The suspect left the area in a vehicle. The victim was treated at an area hospital for non-life threatening injuries. The suspect was not located. **This incident does not appear to be random.** 

**Strangulation [Domestic] –** On April 11 at 10:12AM, officers responded to a residence located in the 13800 block of Meadowbrook Rd in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the victim, a 26-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused assaulted and choked the victim before the parties separated. The accused left the residence prior to the police arriving at the home. Non-life threatening injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Milton **TORRES**. Attempts to locate the accused were unsuccessful.

**Brandishing a Firearm –** On April 13 at 1:16PM, officers responded to WAWA located at 15809 Richmond Hwy in Woodbridge (22191) to investigate a brandishing. The investigation revealed the victim, a 26-year-old man, was involved in a verbal altercation with two unknown men inside the business. During the encounter, the men brandished firearms before leaving the store. No injuries were reported. The men left reportedly got into a black 4-door sedan and left the area. The suspects described as two black males wearing darkcolored clothing, were not located.

**Residential Burglary –** On April 12 at 8:02PM, officers responded to the Lofts at Little Creek located in the 3600 block of Quantico Terrace Dr in Triangle (22172) to investigate a burglary. The investigation revealed sometime between 11:00AM and 8:00PM, entry was made into an apartment through the front door which was found damaged. An undisclosed amount of money was reported missing.

**Aggravated Malicious Wounding** – On April 12 at 10:56AM, officers responded to a residence located in the 14700 block of Tamarack Pl in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 27-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim in the back of the head with a barbell. The parties separated and the police were contacted. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as Moris Rosendo **DIAZ-ULLOA**, was arrested.

The investigation revealed the victim, a 22-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and knocked him to the ground. Once on the ground, the accused took money from the victim. The parties separated and the police were contacted. Minor injuries were reported. Following the investigation, the accused, identified as Noah Cinque **WHITE**, was arrested.

**Assault & Battery on a Law Enforcement Officer [LEO] –** On April 12 at 7:26PM, officers responded to the 13400 block of Richmond Hwy in Woodbridge (22191) to investigate a public intoxication. Officers made contact with the accused who showed signs of intoxication and was injured from a fall. The accused was uncooperative with rescue services and was detained. During the arrest, the accused struck and kicked officers before she spat on the officers. Minor injuries were reported. Following the investigation, the accused, identified as Khadijah Ayesha CAMPBELL, was arrested.
