**Aggravated Malicious Wounding \*ARREST** – On April 15, 2025, the suspect, identified as Rene **DELCID ROMERO**, who was sought in connection to the stabbing that was reported to have occurred in the 8000 block of Stream Walk Ln. in Manassas (20109) on October 29, 2024, was arrested.

**Aggravated Malicious Wounding [Previously Released]** – On October 29 at 10:26PM, officers responded to the 8000 block of Stream Walk Ln. in Manassas (20109) to investigate a stabbing. The investigation revealed the victim, a 41-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused cut the victim multiple times before the parties separated and the accused left the area. The victim was treated at an area hospital for serious, non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Rene **DELCID ROMERO**. Attempts to locate the accused have been unsuccessful.

## Incidents

**Strangulation** – On April 12 at 1:19PM, officers responded to investigate an assault that was reported to have occurred in the area of 8100 block of Bethlehem Rd in Manassas (20109) on April 11 at approximately 9:30PM. The investigation revealed the victim, a 23-year-old man, and an acquaintance, identified as the accused, were involved in a physical altercation. During the encounter, the accused placed his hands around the victim's. The struggle continued until the parties eventually separated. Minor injuries were reported. Following the investigation, officers obtained an arrest warrant for the accused, identified as Angel Manuel **REYES-TLATELPA**. Attempts to locate the accused were unsuccessful.

## Arrests

**Malicious Wounding** – On April 14, officers concluded an investigation into an assault that was reported to have occurred at Youth for Tomorrow located at 11800 Hazel Circle Dr in Bristow (20136) on April 6 at approximately 10:00AM. The investigation revealed a staff member attempted to restrain a juvenile resident, identified as the accused, who was involved in a fight with another resident. During the encounter, the accused headbutted the staff member and stabbed him with two metal screws. A vehicle was also damaged by the accused. Minor injuries were reported. On April 14, following the investigation, officers obtained charges against the accused, identified as a **13-year-old male juvenile**.
