

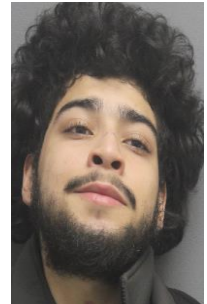


DAILY INCIDENT REPORT

April 21, 2025

Incidents

Malicious Wounding (Domestic) – On April 20 at 2:51AM, officers responded to a residence located in the 14300 block of Southgate Ct. in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the victim, a 16-year-old male juvenile, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused assaulted and then stabbed the victim with a knife before leaving the area. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Derys Alexander **ORTIZ URQUIZA**. Attempts to locate the accused have been unsuccessful.

Strong-Arm Robbery – On April 20 at 1:44AM, officers responded to the Red Roof Inn located at 10610 Automotive Dr. in Manassas (20109) to investigate a robbery. The investigation revealed three men forced their way into a room being rented by the victim, a 56-year-old man. While inside the room, the suspects struck the victim and took his money before leaving the area. Officers and a police K-9 searched the area for the suspects who were not located. Non-life threatening injuries were reported. The suspects were described as one white male and two black males.

Strong-Arm Robbery – On April 18 at 6:04PM, officers responded to Potomac Mills located at 2700 Potomac Mills Cl. in Woodbridge (22192) to investigate a robbery. The investigation revealed the victim, a 15-year-old male juvenile, was sitting in a chair inside the shopping center when he was approached by three unknown males, possibly juveniles. During the encounter, the suspects punched the victim and knocked him to the ground where they then took the victim's shoes and left the area. No injuries were reported. The suspects were described as two Hispanic males and one black male.

Shooting into a Residential Dwelling – On April 20 at 6:25PM, officers responded to a residence located in the 3600 block of Morgan Ct. in Dumfries (22026) to investigate a destruction of property. The investigation revealed sometime between January and April gunfire struck the home. No injuries or additional property damage were reported. A bullet fragment was recovered inside the home.

Commercial Burglary – On April 20 at 9:45AM, officers responded to the Taste of India restaurant located at 14706 Lee Hwy. in Gainesville (20155) to investigate a burglary. The investigation revealed sometime overnight entry was made into the business through an unsecured door. An undisclosed amount of money and bottles of wine were reported missing.

Commercial Burglary – On April 20 at 5:28AM, officers responded to Burger King located at 2211 Tacketts Mill Dr. in Woodbridge (22192) to investigate a burglary. The investigation revealed sometime between 1:30AM and 4:54AM, forced entry was made into the business through the drive-thru window. No property was reported missing.

Commercial Burglary – On April 19 at 11:47AM, officers responded to Halima African Hair Braiding located at 14547 Richmond Hwy. in Woodbridge (22191) to investigate a burglary. The investigation revealed sometime between 11:00PM on April 18 and 7:00AM on April 19, entry was made into the business through the rear door which was found unsecured. Hair care supplies were reported missing.

Commercial Burglary – On April 19 at 4:32AM, officers responded to the Tobacco & More store located at 7385 Miramar Dr. in Manassas (20109) to investigate an alarm activation. The investigation revealed a large rock was used to break out the front glass window. Surveillance footage revealed three unknown men entered the business taking tobacco products and money before leaving. The suspects were last seen wearing face masks and dark-colored clothing.

Indecent Exposure – On April 18 at 3:23PM, officers responded to Burlington Coat Factory inside Potomac Mills located at 2700 Potomac Mills Cl., Woodbridge (22192) to investigate an indecent exposure. The investigation revealed the victim, a 40-year-old woman, was in the checkout line when she observed an unknown man near the exit, exposing himself. The man then re-clothed himself and left the store. No other contact was made between the victim and the suspect. The suspect was described as a Hispanic male, approximately 30 years old, last seen wearing sunglasses, a grey shirt and black jogging suit pants.

Arrests

Malicious Wounding | Assault & Battery on a Law Enforcement Officer [LEO] – On April 20 at 1:00PM, officers responded to a residence located in the 14700 block of Statler Dr. in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the victim, a 58-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim multiple times before stabbing her with a knife. The accused then pushed another family member who attempted to intervene. The accused left the residence and encountered responding officers who attempted to detain him. The accused assaulted three officers before being detained without further incident. Minor and non-life threatening injuries were reported. Following the investigation, the accused, identified as Alexander Craig **SASSIN**, was arrested.

Strangulation (Domestic) – On April 19 at 4:15PM, officers responded to the 16800 block of Miranda Ln. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 46-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation in the parking lot that escalated. During the encounter, the accused struck the victim multiple times before grabbing her neck. The parties eventually separated, and the victim left the area. Officers located the accused nearby and took him into custody. The accused refused to provide identifying information. Non-life threatening injuries were reported. Following the investigation the accused, only identified as an **adult man, was** arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On April 19 at 4:15PM, during a separate investigation in the 16800 block of Miranda Ln. in Woodbridge (22191), officers encountered an intoxicated individual. The individual, identified as the accused, was observed driving a vehicle in a parking lot intoxicated. When officers attempted to detain the accused, she actively resisted and kicked an officer before being detained without further incident. The officer reported a minor injury. Following the investigation, the accused, identified as Shalem Elaine **GORDON**, was arrested.

Sexual Assault Investigation – On April 16, 2025, detectives concluded the investigation into a sexual assault that was reported to have occurred at a residence located in the Woodbridge (22192) area of Prince William County Police in November 2023. The investigation revealed the victim, who was an adult female, was sexually assaulted by an acquaintance, identified as the accused. Following the investigation, detectives obtained arrest warrants for the accused, identified as Marvin Ernesto **MACIAS CORONADO**, who on April 16, was arrested in Fairfax County.

Felony Child Neglect – On April 18 at 7:19PM, officers responded to the 13500 block of Bentley Cl. in Woodbridge (22192) to investigate a found child. The investigation revealed the victim, a 2-year-old boy, was found in the backyard of a residence on Bentley Cl by a Good Samaritan. Officers determined the victim's parents, identified as the two accused, had lost track of the child while they were attending a gathering in the 13400 block of Minnieville Rd. The accused later reported their child missing to the police. The child did not appear injured and was released to the custody of known parties. Following the investigation, the accused, identified as Thomas **TELILA** and Fasika **GIRMA**, were arrested.

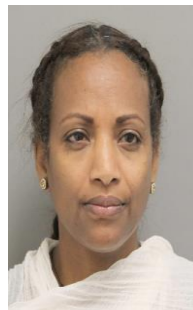
