### Incidents

**Reckless Handling of a Firearm** – On April 23 at 8:39PM, officers responded to the area of Featherstone Rd. and Arizona Ave. in Woodbridge (22191) to investigate a shots fired call. Officers were in the area for an unrelated call when they heard multiple gunshots nearby. The investigation revealed a sedan was traveling eastbound on Featherstone Rd. when the driver of the vehicle fired multiple rounds into the air before driving out of the area. No injuries or property damage were reported.

**Vandalism on School Grounds** – On April 23 at 12:16PM, the School Resource Officer assigned to Colgan High School located at 13833 Dumfries Rd. in Manassas (20112) was made aware of vandalism found inside a school textbook. The investigation revealed swastikas and derogatory language were drawn in the textbook. The drawings were recently observed and reported to school personnel. None of the writing appears to contain any threats towards students or staff. No additional markings were reported.

### Arrests

**Assault & Battery on a Law Enforcement Officer [LEO]** – On April 23 at 7:24AM, the School Resource Officer assigned to Osbourn Park High School located at 8909 Euclid Ave. in Manassas (20111) was assaulted by a student in crisis. While students were entering the school, the student, identified as the accused, approached the officer from behind and struck him with a metal water bottle on the head before immediately attempting to grab the officer's holstered firearm. The officer was able to maintain possession of his firearm and detained the accused without further incident. The officer was treated at an area hospital for non-life threatening injuries. The accused, identified as a **15-year-old male juvenile**, was arrested.

**Assault & Battery on a Law Enforcement Officer [LEO]** – On April 22 at 5:59PM, officers were in custody of the accused at Sentara Northern Virginia Medical Center located at 2300 Opitz Blvd. in Woodbridge (22191) for an evaluation. While in custody, the accused struck two officers and hospital personnel before being detained without further incident. Minor injuries were reported by the officers and hospital personnel. Following the investigation, the accused, identified as Hawa **KALOKO**, was arrested.

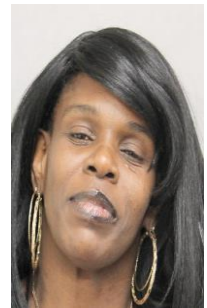

**Threats to Bomb** – On April 23 at 9:01AM, the School Resource Officer (SRO) assigned to Potomac Middle School located at 3130 Panter Pride Dr. in Dumfries (22026) was notified of a threat towards the school. The investigation revealed a woman, later identified as the accused, was involved in a verbal altercation with school personnel while in the main office, that escalated. During the encounter, the accused threatened to bomb the school before leaving the school. Following the investigation, the SRO obtained arrest warrants for the accused, who later returned to the school's main office where she was detained without incident. Officers determined there was no active threat to the school, students, or staff. Following the investigation, identified as Candice Sherrell **LOGAN**, was arrested.

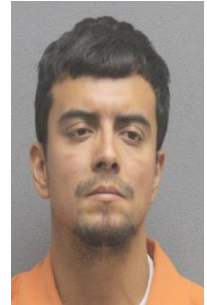

**Sexual Assault** – On April 23 at 3:47PM, officers responded to the 8100 block of Community Dr. in Manassas (20109) to investigate an assault. The investigation revealed the victim, a 29-year-old woman, was walking in the above area, when she was approached by an unknown man, later identified as the accused. During the encounter, the man stopped next to the victim and inappropriately touched her before leaving the area. While investigating the incident, the accused returned to the area where he was detained and found in possession of suspected illegal drugs. During the investigation, officers determined a second woman was assaulted and also inappropriately touched by the accused prior to officers arriving in the area. No injuries were reported. Following the investigation, the accused, identified as Edwin Alberto **MENDOZA**, was arrested.
