### Incidents

**Shooting Investigation** – On April 24 at 1:48PM, officers responded to the 14900 block of Enterprise Ln. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed there was a verbal altercation between occupants of a parked red sedan before one of the occupants got out of the sedan. Shortly after, an exchange of gunfire occurred between the occupants of the sedan and pedestrians in the area. The sedan quickly drove out of the area, and the other parties left on foot prior to the police arriving on scene. Officers and a police K-9 searched the area for anyone involved in the incident who were not located. Officers determined the rounds struck a residence, and one of the rounds entered the home, causing debris to cut a resident who was inside the home. Officers also located an unoccupied vehicle struck by gunfire. No additional injuries or property damage were reported. Officers located shell casings and bullet fragments at the scene. The investigation continues.

**Malicious Wounding** – On April 24 at 1:36PM, officers responded to the 7300 block of Miramar Dr. in Manassas (20109) to investigate a stabbing. The investigation revealed the victim, a 35-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused cut the victim with a knife before fleeing the area. The victim was treated at an area hospital with non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Adrian **BASILIO ESPINOZA**. Attempts to locate the accused have been unsuccessful.
