DAILY INCIDENT REPORT

Incidents

Officer-Involved Shooting Investigation – On April 26 at 9:58AM, officers initially responded to an apartment within the Westminster at Lake Ridge Senior Living Home located at 12191 Clipper Drive in Woodbridge (22192) for a report of a man in crisis armed with a knife. Upon confronting the man inside the residence, he approached officers with the knife and disregarded their commands. Officers fired multiple rounds before the man disengaged with them and began an attack on the victim, identified as a 91-year-old woman, leading to officers discharging their weapons again. Officers provided first aid to both the male and the female. The female was flown to an area hospital for serious injuries and is expected to recover. The male died at the scene. No officers determined during the incident, which remained contained to the residence. During the investigation, officers determined the parties involved were related. There was also one additional adult female inside the residence during the incident who was not injured. The deceased has been identified as Joseph Anthony **CASSELL**, a 26-year-old man. The Prince William County Police Department, at the request of Chief Peter Newsham, has requested the regional Critical Incident Response Team (CIRT) to oversee the investigation as an independent body. More information will be released when available. The investigation continues.

Death Investigation – On April 27 9:11PM, officers responded to the Seven Market located at 1551 Featherstone Rd. in Woodbridge (22191) to investigate a death. The investigation revealed a 67-year-old man was inside the business when he fell unconscious, possibly due to a medical emergency. Another patron located the man shortly thereafter and contacted emergency services. Fire and rescue personnel transported the man to an area hospital where he died. The body was transported to the Medical Examiner's Office for an autopsy and determination of cause of death. At this time, there is no foul play concerning the death. The investigation continues. More information will be released as necessary.

Death Investigation – On April 26 at 8:07PM, officers responded to the 14200 block of Bremerton Dr. in Woodbridge (22193) to investigate a death. The investigation revealed a 21-year-old man was located in the nearby wooded area with an injury believed to be self-inflicted. The man was transported to an area hospital where he later died. The body was transported to the Medical Examiner's Office for an autopsy and determination of cause of death. At this time, there is no foul play concerning the death. The investigation continues.

Commercial Burglary – On April 27 at 4:26AM, officers responded to Oze Tobacco and Vape located at 9755 Liberia Ave. in Manassas (20110) to investigate a burglary. The investigation revealed forced entry was made into the business through the glass front door. Video footage revealed three unknown men smashed the front door before entering the business and taking tobacco products along with a cash register. The suspects fled the area in a vehicle later determined to have been previously reported stolen. All three suspects were last seen wearing dark-colored clothing and face masks.

Commercial Burglary – On April 26 at 2:58AM, officers responded to the Exxon located at 17019 Dumfries Rd. in Dumfries (22026) to investigate a burglary. The investigation revealed forced entry was made into the business through the front glass door. Video surveillance footage revealed a masked man smashed the front door before entering the business, where he took an undisclosed amount of money before leaving. Officers and a police K-9 searched the area for the suspect, who was not located. The suspect was last seen wearing dark-colored clothing and a face mask,

Residential Burglary – On April 25 at 5:37PM, officers responded to Bayvue Apartments located in the 1400 block of Bayside Ave. in Woodbridge (22191) to investigate a burglary. The investigation revealed entry was made into the apartment through an unsecured door. An undisclosed amount of money was reported missing.

Arrests

Threats by Electronic Means – On April 24, officers concluded an investigation into an electronic threat that was reported to have occurred at a residence in the 15800 block of Beau Ridge Dr. in Woodbridge (22193) on April 22 at approximately 3:10 PM. The investigation revealed the victim, a 14-year-old female juvenile, was involved in a verbal altercation while on a video call with an acquaintance, identified as the accused, that escalated. During the encounter, the accused threatened the victim while brandishing a firearm. The phone conversation ended shortly after, and the victim reported the incident to a family member who contacted the police. Following the investigation, the accused, identified as a **17-year-old female juvenile**, was arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On April 26 at 10:56PM, officers responded to Rolling Brook Apartments located in the 1700 block of Pine Shadows Way in Woodbridge (22192) to investigate a domestic dispute. While investigating the incident, one of the involved parties, identified as the accused, attempted to leave the residence and pushed an officer before striking another officer. The accused was quickly detained without further incident. No injuries were reported. Officers determined the domestic dispute was verbal only. Following the investigation, the accused, identified as a **13-year-old female juvenile**, was arrested.
