Malicious Wounding – On April 29 at 5:56PM, officers responded to a residence located in the 7700 block of Willow Pond Ct. in Manassas (20111) to investigate a stabbing. The investigation revealed the victim, a 41-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused cut the victim with a machete-style knife before the parties separated. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as Glenn Franklin **DAVIS**, was arrested.

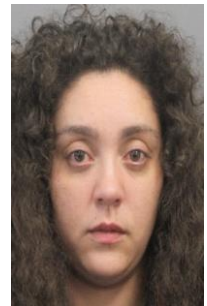

Felony Child Neglect – On April 26 at 12:06AM, officers responded to the 14700 block of Ashdale Ave. in Woodbridge (22193) to investigate a crash. The investigation revealed the driver of the vehicle, identified as the accused, was traveling on Ashdale Ave. when the vehicle left the roadway and struck a parked vehicle before continuing through two different front yards and coming to rest. The accused left the area prior to police arriving on scene. Officers located two additional occupants inside the vehicle, an adult male and a 10-year-old girl. While investigating the incident, officers located the accused at her residence where she was determined to be intoxicated and detained without incident. Both occupants of the vehicle were treated at an area hospital with non-life threatening injuries. Following the investigation, the accused, identified as Jazmine Nichole **CONWARD**, was arrested.

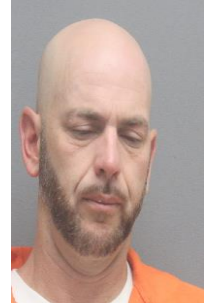

Strangulation | Assault & Battery on a Law Enforcement Officer [LEO] – On April 29 at 1:00AM, officers responded to a residence located in the 7000 block of Signal Hill Rd. in Manassas (20111) to investigate a domestic dispute. The investigation revealed the victim, a 31-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and then grabbed her neck before the accused left the home. The victim reported minor injuries. While investigating the incident, officers located the accused inside a shed located in the backyard. When officers attempted to detain the accused, he actively resisted and struck an officer before being detained without further incident. Following the investigation, the accused, identified as Jeffrey Michael **SIMPSON**, was arrested.

Possession with Intent to Distribute – On April 29 at 8:56AM, the School Resource Officer (SRO) assigned to Colgan High School located at 13833 Dumfries Rd. in Manassas (20112) was notified by school security of a drug tip received through the *See Something Say Something* app. School security brought a male student, identified as the accused, to the security office, where he was found in possession of illegal drugs, nicotine vapes, and THC cartridges. Following the investigation, the accused, identified as a **16-year-old male student**, was charged.
