- **1.** Meeting was **called to order** at 10:01 a.m. and Pledge of Allegiance recited.
- **2. Citizens Time:** Cindy Fox, Mary Davis, and Aiesha Tolbert of the Salvation Army of Prince William County outlined some of the Salvation Army's programs in Prince William County.
- **3. Presentation:** Brian Englmann, Prince William County Demographer delivered a presentation titled, "Prince William County Demographics and Trends: Aging Commission."
 - a. The presentation began with a "County Profile" that included, population, age i.e., under 18 and 65 and over, race and ethnicity, housing units, and group quarters.
 - b. A notable change from 2018 to 2023 is an increase in residents aged 65 and over increased from 9.2% to 10.9%.

- **4. Administrative Items:** Scot Crockett provided a review of documents contained in each attendee's folder.
 - a. Chairman Feeley asked for a motion to approve the January 21, 2025, COA minutes as amended and the updated COA calendar. Sandra made a motion to approve the minutes, Nancy seconded the motion, members unanimously approved the minutes. The January 21, 2025, minutes and updated calendar are approved.
- **5. Directors Time:** Joshua Lee provided updates to ongoing programs, projects, and issues with the PW AAA.
 - a. The current Personal Care waitlist is at 14. The AAA has reduced waitlist by 28.
 - b. The Woodbridge Meals on Wheels waitlist is dynamic; however, currently at 27. There is no wait list for Manassas.
 - c. The Adult Daycare waitlist is currently at 7.
 - d. Hired a HIPPA compliance position per county policy.
 - e. Budget requests submitted that includes four additional positions.
 - f. Proposed CIP for Woodbridge Senior Center has been put forward. County currently looking for land.
 - g. The Agency passed the DARs Audit from October.
 - h. Josh presented an updated Service and Units Summary Report.
- **6. Chairpersons Time:** Mickey Feeley announce his resignation from the Commission.

- 8. Standing and Informational Committee Reports:
 - a. Housing—Housing in the county is more on the demand side than on the supply side.
 - b. NVAN—Advocating with state legislators to get legislative agenda passed
 - c. Woodbridge Senior Center—No Report

- **9. New Business:** Nancy discussed the need to elect a new Chair of the Commission to fill the vacancy. According to the rules the Chairperson position will need to be filled by the April Commissions Meeting.
- **10. Commission Member Announcements:** Eileen reported on efforts to establish a new Senior Center. Brian mentioned that, due to the weather, the Bluebird program has experienced a lot of cancellations in January and February. Scot mentioned ongoing efforts for an adult day care and senior center on the West end of the County. Virginia Governor's Conference on Aging in coming up.
