DOGS ELIGIBLE TO ENTER

This test is open to all breeds. Dogs must be at least 9 months of age and have an AKC registration number, a Purebred Alternative Listing (PAL), AKC Canine Partners number, or a Foundation Stock Service number (FSS). Dogs with physical challenges are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the test. Dogs with bandages, sutures, or visible wounds are not eligible.

ADDITIONAL INFORMATION

A RUN ORDER sign will be posted. It is the exhibitor's responsibility to be ready when it is time to be judged. Judges are NOT required to wait for dogs.

Exhibitors are responsible for cleaning up after their dogs. A Porta-Potty will be on site.

A Qualifying Score Ribbon will be given to each qualifying dog. **Exhibitors are responsible for mailing their qualifying score sheets signed by the judge to the AKC for recording,**

Please follow these guidelines:

- Do not congregate around the secretary's table
- Avoid touching Animals that are not your responsibility.

Please read:

- Dogs will be crated at their vehicle. Bring your own water, food, chair, and shade.
- The Farm Dog Test is non-competitive
 - Dogs must be on a leash at all times while on testing site unless confined in a crate, kennel or vehicle. The leash shall be four to six feet in length. Dogs must wear a secure, well fitting, flat collar during the test evaluation. Handlers can use verbal cues, hand signals, and praise provided it is not excessive in the opinion of the judge.
- Entered dogs will not be permitted into the testing area until their testing time.
- Participants must wait at least 20 feet from the test area.
- NO WANDERING ON THE FARM FOR THE FARM ANIMALS SAFETY!

DIRECTIONS TO TRIAL SITE

From Warrenton VA (Points North): Take Rte. US 211 West, Turn Left onto Rte. 229 South go approximately 6 miles, Turn Left onto Little Forks Church Rd, *Stay on asphalt it becomes Oak Shade Rd, Turn Left onto Cedar Crossing Way at white sign for Three Oaks Farm, Turn Left toward BARN. Follow signs to INDOOR ARENA.*

From Culpeper, VA (Points South): Take Rte. 229 North, Turn Right on Little Forks Church Rd. *Follow rest of the directions above.*
